Welcome and Introduction of members/staff

Overview of the Governor's Vision for the Future of Water Supply in Kansas

Jackie McClaskey, Secretary, Department of Agriculture, and Tracy Streeter, Director, Kansas Water Office, jointly appeared before the Committee to provide an overview of the Governor's vision for water across the state. The following documents were provided to the Committee:

- A Long-Term Vision for the Future of Water Supply in Kansas (Attachment 1).
- Progress: Phase I Action Items (Attachment 2)
- Final Regional Goal Terms(Attachment 3)
- 2015 Kansas Legislative Session Water-Related Agenda (Attachment 4)

Mr. Streeter noted that a lot of the emphasis is being placed on two water supplies - the High Plains Aquifer and the reservoirs, noting that there are 24 reservoirs within the State; 17 of these are operated by the Corp of Engineers. Mr. Streeter indicated that there is less than 25 years of water supply in the High Plains Aquifer at this time.

Ms. McClaskey stated that one factor discovered by the governor's task force is that not all solutions for water work for all Kansans and all areas of the state. Some of the priority action items include improving coordination on water related issues at the executive level with additional regular agencies; establish blue-ribbon task force to develop a balanced, affordable and sustainable method to provide financing for water resource management and protection; including alternatives that utilize public and private partnerships. Other issues to be addressed include treatment of "pre-used" water; use of water by the oil and gas industry and increasing water storage.
