Bill Introductions

There were no bill introductions.

Presentation on:

Dr. Bill Brown, Kansas Livestock Commissioner, appeared before the Committee to present an update on livestock brands in the state. Dr. Brown noted that branding as a form of identification of cattle was set in statute in 1939. Dr. Brown stated that the Department must maintain all brand applications made since 1939.

Presently, the application process for a brand has been digitized and application can be made online - application for a brand has a fee of \$45 with the brand good for 5 years before renewal is necessary. Dr. Brown noted that there are 17,500 brands presently registered. There are also six places to locate the brand on an animal allowing the same brand to be used six times in different locations on the animal.

The Commissioner stated that the Commission partners with the Attorney General's office in working to locate stolen cattle.

Dr. Brown responded to questions from the Committee.

Kendal Lothman, Special Agent, Attorney General's Office, presented testimony on branding and cattle rustling (Attachment 1). Mr. Lothman stated the new Livestock/Brand Investigation Unit was created by the Kansas Attorney General after entering into a joint agreement with the Department of Agriculture to increase efforts to combat cattle theft in the state. The Unit will investigate felony

livestock thefts, felony livestock pharmaceutical thefts and felony brand violations.

Mr. Lothman noted that livestock theft is a widespread issue across the nation. Kansas has approximately 5.8 million head of cattle within the state and 48 livestock markets with approximately 2,146,160 cattle sold in 2013. Only six of the livestock markets in the state do brand inspection, allowing stolen livestock to be easily sold through the market place.

Mr. Lothman responded to questions from the Committee.
