Briefing on:

Gary Harshberger, Chair, Kansas Water Authority, appeared before the Committee to present the Kansas Water Authority's recommendations for the legislative session (Attachment 1). A copy of the Kansas Water Authority's annual report was distributed to the Committee (copy available on their website or from the Kansas Water Authority).

Mr. Harshberger stated that the Water Authority's role is to provide recommendations for the coming year as well as plan for future needs for water and funding of projects. Mr. Harshberger noted that the agency is working with the Kansas Water Office, Department of Agriculture and other interested parties to develop a 50-year vision for the state's water supply. The Chairman noted that water resources are diverse across the state and the goals will need to be diverse as well. Mr. Harshberger noted that teams of individuals from each region of the state are working to determine the best goals for each region.

In response to a question from the Committee concerning a listing of the members from each region, Susan Metzger, Department of Agriculture, responded to a question from the Committee stating that a listing of members to the task force is available on the Water Department's website plus information will be made available to the Committee.

Mr. Harshberger indicated that the team's task is to address goals for each region.

Mr. Harshberger responded to questions from the Committee.

Hearing on: HB2061 — Amending the powers and duties of the Kansas department of agriculture division of conservation and the state conservation commission.

Natalie Scott, Revisor, provided an explanation of **HB 2061**, noting that the legislation amends the list of duties the Department of Agriculture Division of Conservation has in consultation with the State Conservation Commission (Attachment 2). In addition the bill creates a conservation fund in the state treasure for the purpose of collecting the fees authorized in the bill.

Responding to a question from the Committee, Ms. Scott noted a similar bill was addressed in the 2014 Legislative Session.

Representative Tom Moxley presented testimony in support of **HB 2061** (Attachment 3). The Representative is an attempt to provide assistance to watershed districts who are struggling with new rules established by the Corp of Engineers. Representative Moxley explained that the legislation is a result of meeting with watershed district stakeholders, farm organizations, Department of Agriculture representatives as well as representatives of the Corp of Engineers in an effort to remedy the Corp of Engineer rules. This legislation provides a more economical alternative for watershed districts and the effect on landowners.

Greg Foley, Executive Director of the Division of Conservation, Department of Agriculture, provided testimony in support of **HB 2061** (Attachment 4). Mr. Foley explained that **HB 2061** amends current Conservation District law to authorize the State Conservation Commission and the Division of Conservation (DOC) to assist local government agencies in their efforts to comply with the federal Clean Water Act. The bill would authorize the DOC to hold easements, to assure completion of restoration projects and to assume third-party responsibility for long-term protection of mitigated stream and wetland sites. Mr. Foley noted that the legislation would allow the Division of Conservation to provide the required third party services to watershed districts and other local government agencies.

Herb Graves, Executive Director of the State Association of Kansas Watersheds (SAKW) presented testimony in support of <u>HB 2061</u> (Attachment 5).

Mike Beam, Sr. Vice President, Kansas Livestock Association (KLA), appeared before the Committee in support of **HB 2061** (Attachment 6).

John Cowley, Kansas Farm Bureau, appeared before the Committee in support of HB 2061 (Attachment 7).

Duane Hund, Contracting Officer, Mill Creek Watershed District #85, provided written testimony in support of **HB 2061** (Attachment 8).
