<u>Hearing on: HB2536 — Amendments regarding accountant licensure.</u>

Chairperson Hutton opened the hearing on this bill. Chuck Reimer gave an overview noting the bill pertains to statutes for the Board of Accountancy.

John Helms, CPA, provided proponent testimony (Attachment 1) noting this bill clarifies laws governing the practice of certified public accountancy and updates the laws to reflect changes in industry standards.

Marlee Carpenter provided proponent testimony (Attachment 2) on behalf of Aron Dunn, CPA, Chairperson, Kansas Society of CPA (KSCPA) Advocacy Task Force. Other supporters are state regulators, American Institute of CPAs, and the National Association of State Boards of Accountancy.

There was no opponent or neutral testimony.

Dr. Stephen Hall gave a presentation (Attachment 4) on employment outcomes for people with disabilities. He reported Kansas trails other states in funding for supported employment for persons with disabilities. He recommended steps to be taken to update the program.
