Approval of Minutes

The February minutes of House Commerce Committee meetings had been sent to Committee members on last week.

<u>Informational Hearing on: State Efficiency Recommendation on Enhance Commerce's Business to Business Strategies, and Ensure no Program Subsidy for Athletic Commission Fee for Service Operation</u>

Secretary Antonio Soave, Kansas Department of Commerce and Adam Roorbach, Director, Athletic Commission, Department of Commerce (Attachment 1), provided comments on these two recommendations.

Secretary Antonio supports the changes but recommends decoupling some programs to allow for more flexibility and efficiency in the use of incentive funds.

Mr. Roorbach said athletic fees can be revenue neutral in two years, and action at this time seems premature.

<u>Informational Hearing on: State Efficiency Study Recommendations, KDOL Assessment Rate Change, Replace Worker's Compensation State Self Insured Fund (SSIF) Claims Management with an Experienced Third Party Administrator</u>

Justin McFarland, Kansas Department of Labor (Attachment 2); and Rey Mesa, Senior Government Affairs Director, Kansas Chamber, provided comments (Attachment 3). Changing the basis for the assessment from claims paid to total written premium should be studied. The Kansas Chamber is not opposed to the assessment rate change if the revenue is neutral and not tied to funding a new office of risk management.

A letter from the National Council on Compensation Insurance <u>Attachment 4</u>) referenced in Mr. Mesa's comments, indicated some of the figures contained in the study may be wrong. The change in assessment by written premium may be less than the current method by claims paid.

Written-only comments were provided by Natalie Bright, Kansas State Council Society for Human Resource Management (Attachment 5). Also, written-only comments were provided by Mike Michael, Director, State Employee Health Benefits Plan, KDHE (Attachment 6); and Carrie Doyal, KDHE, was present to answer any questions.

Chairperson Hutton asked the Committee members to consider this bill. Chuck Reimer distributed an amendment (Attachment 7) and explained it.

Representative Mason moved, seconded by Representative Carpenter, to adopt the amendment. The motion carried.
