## Discussion and action on: SB365 - Enacting the contaminated property redevelopment act.

Chairperson Hutton asked the Committee's desire on this bill. Chuck Reimer, Revisor, gave an overview. The bill would establish the Contaminated Property Redevelopment Act, which would allow a purchaser of real estate property acquired after July 1, 2016, to be released from environmental liability for pre-existing contamination.

<u>Representative Mason moved, seconded by Representative Carpenter, to pass the bill. The motion</u> carried.

# <u>Discussion and action on SB366 - Prohibiting price controls on the purchase or sale of private residential or commercial property.</u>

Chuck Reimer, Revisor, gave an overview of the bill. This bill would expand the statute to prevent cities and counties from controlling the rental or purchase price agreed upon for privately owned residential or commercial property.

Representative Carpenter moved, seconded by Representative Mason, to pass the bill.

Mr. Reimer distributed and explained the amendment (Attachment 1). Representative Hutton explained this would allow an exclusion whereby the private owner and city could get together and agree to a voluntary program.

The motion failed.

The Committee voted on the motion to pass the bill. The motion carried.
