Both the legislature and KSDE have been discussing the possibility of future funding for reading intervention programs. The strongest consideration is being given to putting together funds that would provide multiple reading intervention programs with multiple years of funding. In this way, schools could select which reading intervention programs they would like to use. Training and support would also be provided as part of this program. Only computer based reading programs that meet certain fidelity criteria would qualify. In all likelihood KSDE would be involved in doing an independent evaluation of the results. We would like to assess the level of interest for this type of program from Kansas Schools and intend to share the results with selected Legislators and KSDE (only summary data will be shared). We believe this would give schools an effective option and let the results speak for themselves. Please complete the following two questions.

The survey was emailed to over 1900 in Kansas schools, including teachers, principals and superintendents. Over 400 individuals opened or read the email and 190 completed the survey.
