Bill introductions:

Chairman Brunk opened the meeting at 9:05 am. and called for any bill introductions.

Representative Brett Hildabrand introduced two bills:

- 1. A bill regarding data privacy and penalties for non compliance.
- 2. A bill mandating GASB accounting requirements for Kansas school districts.

Representative Janice Pauls introduced a bill about bingo.

Representative Steven Becker introduced a bill regarding income taxation relating to credits and individual development account programs.

All the bills were received without exception.

<u>Hearing continuation on: HB2007 — Creating a law enforcement mutual aid region for critical incidents.</u>

Chairman Brunk opened the hearing for comments and clarifications from some of the parties to the bill

Ed Klumpp spoke first stating that a tentative compromise agreement was in the works. "We are going over the draft of the bill with the revisor and there may be some minor changes in the wording. So we may come to an agreement and withdraw our opposition. We are working on a better definition and clarifying changes. These alterations could create an agreement that would withdraw our opposition because there would be better definition and clarification. There are still some questions particularly on lines 8, 9 and 10 as to how to frame the definition. Jason Long in the revisor's office is assisting on the issues."

Fred Farris commented that they had heard the questions and worked them out and the conflict is gone.

Representative Melissa Rooker said that her district number 25 borders Missouri with 8 cities and 5 Chiefs of Police. She said that they cross over the state line without any problems. They have a school that straddles the state line and a country club with the club in one state and the parting lot in the other. She wants there to be a compromise and go on to the next step of cooperation.

Jason Long gave the committee a briefing on how HB2007 differs from existing law, namely K.S.A. 19-828 which was first enacted in 1999 as part of a broader act aimed at enforcement of controlled substances laws. (Attachment 1)
