**Bill introductions:**

Representative Stephanie Clayton introduced a bill about Rotary Clubs.

Representative Richard Jones introduced a bill to reintroduce quarter horse racing to Kansas.

Representative Randy Garber introduced a bill about agriculture.

Representative Travis Couture-Lovelady introduced a bill authorizing microbreweries to manufacture and sell hard cider and mead.

They were all received without exception.

Chairman Brunk called the committees attention to the three house bills that were introduced by ABC that are under consideration today and said that they would be treated individually.

**Final action on: HB2089 — Alcoholic beverages; disqualification of hidden owners from licensure.**

Chairman Brunk called upon the committee to work **HB2089**. Jason Long gave a briefing on the the three bills under consideration today, **HB2088**, **HB2089** and **HB2125**.

Representative Travis Couture-Lovelady made a motion to pass **HB2125** out favorably for passage, seconded by Representative Bud Estes.

Jason long offered a balloon amendment for **HB2125** and explained the amendment. ([Attachment 1](#)). Representative Nancy Lusk seconded the amendment. The amendment carried.

Representative Travis Couture-Lovelady made a motion to pass **HB 2125** out favorably as amended, seconded by Representative John Wilson. The motion carried.

**Final action on: HB2088 — Alcoholic beverages; issuance of citations by the division of alcoholic beverage control.**

Chairman Brunk called upon the committee to work **HB2088**. Jason Long presented a briefing on the changes to the bill.

Representative Lane Hemsley made a motion to pass **HB2088** out favorably for passage, seconded by Representative John Wilson.

Representative Todd offered an amendment to require a signature at the time of the violation of the name and date of the person receiving the citation, seconded by Representative Brett Hildabrand. The motion failed.

Chairman Brunk called for a vote on the motion to pass the bill. **HB2088** was approved by voice vote.

Chairman Brunk reminded the committee of the informational meetings planned for Wednesday and Thursday.
