for student athletes with head injuries.

Bryan Kendall Payne, D.C., (Attachment 3), spoke in favor of HB2578 noting that chiropractic physicians are trained and educated in the diagnosis and treatment of concussions and are often times the treating physician of the head injury patients.

Questions were asked and comments made by Representatives: Scott Schwab, Blake Carpenter, Les Osterman, and Randy Powell.

Ryan King, (Attachment 4), spoke as a student athlete who suffered concussions as an athlete and noted the only relief he got as a head injury patient was from the chiropractic community.

Questions were asked and comments made by Representatives: Willie Dove, and Ron Estes.

Written Proponents:

Steven J. Gould, D.C. (Attachment 5) offered written testimony in support of this bill. He noted that chiropractors are providing services in this enlarging role of care due to school budget changes, shortage of athletic trainers, and shortage of medical/osteopathic doctors to provide these services.

Jason Qualls, D.C. (Attachment 6), offered testimony as a proponent to **HB2578** from the perspective of a school that trains chiropractors.

Dara Summers (Attachment 7), gave written testimony as a proponent to the bill and noted how the chiropractic community helped her during her head injury ordeal.

Dr. Pete Workman, (Attachment 8), presented testimony as a proponent, relating his experience of a Dr. for student athletes.

Tim Lackey, (Attachment 9), offered written testimony in support of **HB2578** noting his experience as a team doctor at Buhler High School.

Sean Hubbard, (Attachment 10), presented testimony in support of the bill and noted that he has not found any incident of a chiropractor ever sending an athlete back to play erroneously in any of the 40 states that allow chiropractors to make that decision.

Marcia Kampling, (Attachment 11) offered testimony in support of **HB2578**.

Todd Hague, (Attachment 12), noted the benefits to the Cheney High School athletic department that their chiropractic doctors offers their school and athletes.

# Opponents:

Bob Williams, (Attachment 14), spoke as an opponent to <u>HB2578</u> noting that previous legislation that was well thought out, had decided, in the interest of the student athletes, is best if only a physician signed the "Return to Practice" form.

# Written Opponents:

Dr. Bart Grelinger, (Attachment 15), offered written testimony in opposition to **HB2578**. He shared his perspective on this issue from the perspective of a board certified Neurologist.
