### **Possible bill introductions**

The following bills were introduced as committee bills without objection:

Kevin Davis, Director of Governmental Affairs and Counsel, Security Benefit Life, amend various statutes that will provide modernization of the investment statutes.

Bill Sneed, Legislative Counsel, Hyatt Legal Services, change wording to replace technical insufficiencies in the current law.

Clark Shultz, Director of Governmental Affairs, Department of Insurance, update the current date to extend the expiration date of the Property and Casualty actuarial opinion law.

Clark Shultz, Director of Governmental Affairs, Department of Insurance, amend fraudulent insurance act and amend external review of adverse health care decisions.

Representative Anthimide, increase minimum auto insurance liability by \$25,000.
