Those opponents are Steve Brunk on behalf of Citizen Link Family Policy Alliance (Attachment 35), Michael Schuttloffel, on behalf of the Alliance Defending Freedom (Attachment 36) and whose testimony includes an attachment (Attachment 36A), and Michelle Schroeder, on behalf of the State Family Freedom Alliance of Kansas (Attachment 37). Additional questions were asked of Ms. Fiedorek by Representatives Mark Kahrs, Les Osterman, and Craig McPherson.

Chairperson Barker noted that there was written neutral testimony by the Kansas Human Rights Commission (Attachment 38).
