Clancy Holeman presented testimony in support of **HB2477** by describing the need to speed up the process of collecting delinquent taxes sooner than the current law allows. (Attachment 7) He stood for questions.

Nathan Eberline presented testimony neutral to **HB2477** by pointing out some minor concerns the county association has with the proposed changes. (Attachment 8) He stood for questions.

Thomas Franzen presented testimony in opposition to **HB2477** by detailing the associated costs Johnson county would incur if the bill is passed. (Attachment 9) He stood for questions.

Linda Coon presented testimony in opposition to **HB2477** by describing the statewide county treasurers association's varied opinions concerning the bill and stating her county's ability to work with delinquent taxpayers. (Attachment 10) She stood for questions.
