Bill introductions

Update on: Kansas Motor Carriers

Chairman Proehl introduced Tom Whitaker, Executive Director for the Kansas Motor Carriers Association. Mr. Whitaker drew the Committee's attention to a listing he had prepared of places, locations and licensing services provided. (Attachment 1)

Mr. Whitaker proceeded to walk the Committee through "Trucking 101" which was a brief overview of trucking in Kansas. (Attachment 2) He said the trucking industry provides over 74 thousand jobs and pays 45 percent of all taxes and fees owed by Kansas motorists even though trucks represent only 10 percent of the miles traveled on Kansas roads.

Mr. Whitaker also discussed electronic logging devices and the latest rulemaking by the Federal Motor Carrier Safety Administration. (Attachment 3)

After all questions were answered, Chairman Proehl thanked Mr. Whitaker for the presentation.
