I am writing to advise the Joint Committee on State Building Construction of a project that the University of Kansas Medical Center wishes to construct under the authority of K.S.A. 76-759. The project is the renovation of the first floor of Sudler Hall to create a new simulation center that will be used by the Medical Center to educate healthcare providers, students and faculty. The center will also be used by the KU Hospital to engage its medical staff and other healthcare providers in simulations that will enhance skills, promote collaboration and preparedness, and ultimately provide for better patient care. The cost to renovate, equip, and operate will be shared equally by KUMC and the KU Hospital. This new simulation center will be complementary to the simulation space that is being planned in the new Heath Education building.

The project includes renovation of approximately 8,583 gross square feet of space. The simulation center will include office space, storage space, a full scale operating room, an ICU/general patient ward suite, and a skills training space. The estimated cost of the project is \$1.1 million and will be jointly funded by the KUMC Research Institute and the KU Hospital Authority.

K.S.A. 76-759 authorizes university research foundations to initiate and construct capital improvement projects on state-owned property of the university with the approval of the Board of Regents. The project must be funded with nonstate money and the plans and specifications for the capital improvement projects must be approved by the secretary of administration. The improvements become the property of the state of Kansas upon completion and acceptance by the secretary of administration.

The statute further requires that the Joint Committee on State Building Construction be advised and consulted before the project is approved by the state board of regents. The University of Kansas Medical Center is seeking Board of Regents approval to amend its FY 2015 Capital Improvements to include the Simulation Center in Sudler Hall.

In accordance with K.S.A. 76-759, the university is advising/consulting the committee, a program statement is attached. Please let us know if there are any questions or if you need additional information.

#### **NARRATIVE**

The University of Kansas Medical Center continues development in the areas of education, research and patient care. The University of Kansas Hospital is committed to partnering with KUMC for a new simulation center. Medical Simulation is already conducted on campus in very tight spaces, well below the national average for a modern medical research university. The program, budget, and plan shown here will increase the capacity for the following training goals: interpersonal and communication skills, leadership and team training, procedure training, and diagnostic reasoning.

### PROJECT SCOPE

This facility is planned to be housed in the ground floor of Sudler Hall. Existing space will be demolished to the structure. Fire alarm and sprinkler for all of the ground floor are being upgraded in another project. MEP systems will be redone to serve the new spaces of the simulation center only.

### COST OF SERVICING BUILDING

The cost of servicing the building will continue to be provided by KUMC with possible future support from the University of Kansas Hospital. Initial servicing costs for ground floor Sudler will be less than currently spent because of new HVAC distribution and plumbing.
