Kansas Juvenile Justice System Trends

- Intake and Assessment Events have reduced by 24% from FY09-FY15
- According to OJA stats, there has been a 33% reduction of juvenile cases filed from FY09-FY14
- JISP average month end population is down 31% from FY09-FY15, 24% since FY11
- Custody average month end population is down 16% from FY09-FY15, 16% since FY11
- JCF average month end population is down 24% from FY09-FY15, 12% from FY14.

JCF Trends/Updates

- Both JCFs earned licensure from KDADS for substance abuse treatment
- Both JCFs earned PREA certification
- Overhaul of Assessments and Programming
 - RDU process improved and is incorporating trauma assessments
 - Sex Offender Assessments and Treatment
 - Anger Replacement Therapy
 - Substance Abuse Assessments and Treatment
 - CBT Thinking for a Change
 - Establishing Family Therapy
 - Re-entry Services
 - Mentoring Services
- Training for Staff

Education Updates

- 65 JCF youth obtained GED or High School Diploma in FY15
- Certifications and/or courses available which are indemand (e.g., welding, electrical, construction, plumbing, manufacturing skills)
- Collaboration with Kansas Kids GearUp
- Work Ready Career and Life Skills Workshops
 - Job Search
 - Financial Literacy Workshops
 - Resume Writing
- Increased staff certified in OWDS

Post-Secondary Hours – JCF FY11-FY15

Post-Secondary Credit Hours for KJCC

As noted in the below chart, the number of post-secondary credit hours awarded for youth at KJCC in FY15 was 1215, a <u>813% increase from FY13 numbers.</u> Female youth at KJCC (9% of population) earned a proportional number of the hours (11%).



Barton Community College Credit Hours for LJCF

LJCF youth earned 367 hours in FY15, a slight decrease from FY14 and level with FY13 numbers.

CSG Resource and Recommendations

Core Principles for Improving Youth Outcomes:

- Base supervision, service, and resource allocation decisions on the results of validated risk and need assessment
- Adopt and effectively implement programs and services demonstrated to reduce recidivism and improve other youth outcomes, and use date to evaluate the results and direct system improvements
- Employ a coordinated approach across service systems to address youth's needs
- Tailor system policies, programs, and supervision to reflect the distinct developmental needs of adolescents

Update on Recommendations

- Juvenile Services Leadership Team Established
- Systematic review and assignment on each recommendation
- Examples:
 - New standards for requiring YLS reassessment every 6 months regardless of placement
 - New policies for our staff and training of JCF staff in YLS with new interview guides
 - In the process of working with CSG on the norming process for Kansas on the already validated YLS
 - Increased training for ISP staff, provider staff and JCF staff
 MI, EPICS, Mental Health in Juvenile Justice (MHJJ)

Update on Recommendations

- Standard issued requiring default releases from JCF to home with process for requesting exceptions.
- Contract expectations for providers modified for FY16 to include training requirements and program components, target population definition, etc.
- Improvements in Technical Assistance and Quality Assurance (QA) and plan for QA tool usage for JCF and supervision agencies
- Report Development (e.g., Risk Level in various system points – ISP, Custody, JCF) Using more data to drive system/policy decisions
- Review resources for development of additional EBP

Out of Home Placements

- Juvenile Services invests significant amounts of resources in community out of home placements
- In Fiscal Year 2012, nearly \$32 million was spent in various residential placements
- In Fiscal Year 2015, expenditures were nearly \$25.5 million (\$6.5 million reduction)
- Roughly \$14 million was spent in FY15 on Youth Residential Centers (largest model type)
- 2015 YRCII study found most youth don't successfully complete program
- Kansas is a high consumer of residential placements (6th highest nationally)


Strategies to Improve Outcomes – EBP Community Investment

MST Program

- The Wyandotte County pilot site began accepting youth in mid-September 2013
- Represents a new way of doing business in collaborating with multiple community partners
- Structured Decision-Making Matrix developed and applied
- Strong Local Judicial Leadership
- Custody numbers decreased in WY County roughly 34% from (8/31/13 to 9/30/15)
- Plans to allow Johnson County youth


WY County Custody Trends FY08-FY16 YTD



Functional Family Therapy Pilot

- 2015 Legislature allocated \$500K for expansion of evidence-based programs.
- Functional Family Therapy (FFT) is an outcome-driven prevention/intervention program for youths and their families ages 11-18.
- The program targets youth who are at risk for and/or presenting with delinquency, violence, substance abuse, conduct disorder, oppositional defiant disorder, or disruptive behavior disorder.

Functional Family Therapy Pilot



- Services to be provided in 7 judicial districts in Southeast Kansas.
- MOUs developed with each JD outlining joint commitment to reduce custody placements by 20% or more.
- Estimated 1/1/16 start date

Other Initiatives

- Re-Investing Some Savings from Group Homes Reductions
 - Regional Functional Family Therapy (FFT) RFP
 - Community Sex Offender Assessment/Treatment RFP
- Increased Quality Assurance Plan for Community Programs
- Selection by PEW for Intensive Technical Assistance
 - Establishment of Kansas Juvenile Justice Workgroup

PEW Technical Assistance

Inter-branch, bipartisan support for application

6th State to receive TA from PEW

- Georgia, Hawaii, Kentucky, South Dakota, West Virginia
 Other States Have Similar Issues as Kansas
 - Outcomes (e.g., recidivism) unknown or high (45%-75% with 2 unknown)
 - Heavy reliance on out-of-home placement
 - JJ system out-of-step with research (LOS, low-level and low-risk youth in deep end placements)

All 5 had strong legislative support of proposed reform bills

PEW Technical Assistance

- Workgroup formed (17 members)
- Began meeting in June 2015 for a comprehensive review of the juvenile justice system in Kansas

Charge to the Workgroup:

"In developing proposals for reform, the group's priorities will be to:

- Promote public safety and hold juvenile offenders accountable
- Control taxpayer costs
- Improve outcomes for youth, families and communities in Kansas."
