Chairperson Lynn requested approval of the minutes for the March 5, 2015 and March 9, 2015 Senate Commerce Committee meetings. Senator Baumgardner moved, seconded by Senator Longbine, to approve the minutes. The motion passed.

Final action on: SB276 — Integrating certain statutes pertaining to business filings and limited liability companies.

Chairperson Lynn continued the hearing on **SB 276** and requested Revisor Chuck Reimer to update the Committee concerning questions raised on certain provisions of the bill at the hearing on **SB 276**, which began on March 16, 2015. Following the update, there were no further questions for the Revisor.

Chairperson Lynn asked Senator Holland if he had any questions for Kathy Sachs, Deputy Assistant Secretary of State for Business Services, who had provided testimony on March 16, 2015 on **SB 276**. Senator Holland responded he did not have any additional questions and thanked Ms. Sachs for meeting with him to address his questions. Senator Lynn closed the hearing on **SB 276**.

The Committee proceeded to deliberate **SB 276**.

Final action on: HB2267 — Alternative project delivery; notice requirements and selection procedures.

Senator Holland stated he would be voting nay on the bill. He suggested the Committee consider reviewing the State's procurement process. Senator Holland expressed a concern with the Kansas Department of Administration being involved with the analysis of these projects. There was no other discussion.

The motion passed. Senator Holland voted nay.
