MINUTES OF THE SENATE COMMERCE COMMITTEE

Chairperson Lynn recognized Stephen Hall, Ph.D., Director, Employment Policy and Financing, Griffin Hammis Associates, who made a presentation concerning Policy Analysis and Recommendations to Improve Employment Outcomes for People with Disabilities. (Attachment 1)

Dr. Hall stated \$4.3 million, about 0.80 percent is spent on supported and customized employment. Kansas, the first Employment First state in the nation, currently invests four times less than the average state in real community employment jobs. Kansas investment in Supported Employment is over \$3 million less in actual non-adjusted for inflation money than it was 21 years ago. Dr. Hall recommended more of the current funding should be directed to employment at no additional cost to taxpayers. He suggested integrated employment should be increased annually to become 3.4% of every disabilities services total budget, putting Kansas permanently back on the integrated real jobs employment track.

Senator Faust-Goudeau questioned whether transportation assistance is provided for people with disabilities to their work site. Dr. Hall said providing transportation is often built into the labor program.

Senator Denning, recognizing the complicated nature of the issue, questioned if the appropriate cabinet agencies are involved with proposed changes to the program. Dr. Hall responded affirmatively. He said the purpose of speaking to the Committee was to inform members of the need to reform the program and expand the number of people with disabilities who are provided employment opportunities. He referred members to the Kansas Council on Developmental Disabilities to obtain additional information or to answer questions.
