<u>Hearing on: SB365 — Enacting the contaminated property redevelopment act.</u>

Chairperson Lynn opened the hearing on <u>SB 365</u> and requested Revisor Chuck Reimer to provide an overview of the bill.

Chairperson Lynn recognized the following conferees:

Senator Rick Wilborn provided testimony in support of the bill. (Attachment 1)

Chairperson Lynn asked Senator Wilborn what brought this legislation to his attention. He replied it stemmed from his experience working on potential economic development projects in his district.

Leo Henning, Director, Bureau of Environmental Remediation, Kansas Department of Health and Environment, provided testimony in support of the bill. (Attachment 2)

Senator Olson said the legislation would help promote development of sites that have been vacant for years due to environmental issues. He asked if a Certificate of Environmental Liability Release (CELR)

would be attached to the title and whether it would be recorded. Mr. Henning responded the CELR would be in the purchaser's file as they are required to disclose the Certificate to subsequent buyers of the property. The CELR is not transferable. When the property is sold, the new purchaser must make another application for the CELR. Since the bill is not retroactive, there was discussion concerning current property owners who have property with contamination issues. Mr. Henning stated the seller is required to notify the buyer of any contamination. He said there are mechanisms to handle contamination issues on orphan sites.

Senator Denning questioned if a current property owner of contaminated property could sell it to a new owner under this program. Mr. Henning responded affirmatively. There was discussion concerning secured and unsecured loans in relation to these properties.

Senator Denning questioned Kathy Taylor, Kansas Bankers Association, concerning the status of loans for properties that have been foreclosed. He asked if the loan for a property came from the Kansas Department of Health and Environment if it would be an unsecured loan. Ms. Taylor responded this could happen.
