**Final action on: SB101 — Amending the definition of "health care provider" in the health care provider insurance availability act to exclude certain persons.**

The Chairman called for final action on **SB 101**. Melissa Renick, staff revisor, gave a brief overview of the bill and distributed a balloon amendment. ([Attachment 1](#))

*Senator Olson moved, Senator Hawk seconded, to amend **SB 101** as reflected in the balloon amendment. Motion carried. Senator Olson moved, Senator Wilborn seconded to recommend SB 101 as amended, favorably for passage. Motion carried.*

**Final action on: SB117 — Allowing certain health care providers and health care systems to qualify to become self-insurers through the health care stabilization fund.**

The Chairman called for final action on **SB 117**. Melissa Renick, staff revisor, gave a brief overview of the bill. *Senator Bowers moved, Senator Hawk seconded to move **SB 117** favorably for passage. Motion carried.*

**Final action on: SB155 Surplus lines insurance definitions and gross premiums tax.**
