

Hello my name is David Auble and so far I am a cancer survivor . Cannabis kills cancer the Federal department of health has a patent on it number 6630507. A study in 1974 at the VIrginia Collage of Medicine showed that it had anti tumor effects in mice but since it was funded by the DEA who was wanting to prove that it caused tumors to grow it was stopped and the researchers were told to destroy the research .
