## TESTIMONY ON SB 449 SENATE COMMITTEE ON PUBLIC HEALTH AND WELFARE FEBRUARY 15, 2016

Good Afternoon Mr. Chairman and Committee Members:

Thank you for the opportunity to testify today as a proponent of SB 449. I am Max Foster, the Executive Director of the Behavioral Sciences Regulatory Board (BSRB).

As you are aware from my previous testimony to this committee, the BSRB is the licensing board for most of the state's mental health professionals including: licensed psychologists, master level psychologists, clinical psychotherapists, bachelor, master and specialist clinical level social workers, master and clinical level professional counselors, master and clinical level marriage and family therapists, addiction counselors, clinical level addiction counselors, and effective July 1, 2016 – assistant behavioral analysts and behavioral analysts.

SB 449 is legislation which impacts various statutes administered by the BSRB. During the 2015 legislative session, this committee heard testimony on SB 254. SB 254 was sponsored by our agency and the content of the bill affected changes to numerous statutes administered by our agency. During the hearing process this committee heard testimony from stakeholders that were affected by the legislation. As of today SB 254 remains in this committee. Since the 2015 legislative session, the BSRB has had an opportunity to meet with stakeholders who were in opposition to certain provisions of SB 254, and as a result of discussions held at these meetings, SB 449 has been introduced. Therefore, SB 449 is replacement legislation for SB 254.

The following table will illustrate the differences in content between Sb 254 and SB 449.
