Possible bill introductions

There were no bill introductions.

Adam Siebers, Assistant Revisor, informed the committee that **SB 5** would designate a portion of US 69 as the 2nd Lieutenant Justin L. Sisson memorial highway.

Kevin Sisson, father of Lt. Sisson, told the committee about their family connection to Kansas, who Justin was, and why this memorial was important to them and to those who knew Justin. (Attachment 1).

Pam Robinson, President, Blue Valley School Board, shared with the Committee that as the wife of a military officer, she was continually reminded of soldiers' dedication to duty, honor, and country all the

while knowing it could cost them the ultimate sacrifice (Attachment 2).

Michael Seitz, Vice-President of the Blue Valley School Board, noted that his son and Justin were classmates and captains of the wrestling team at Blue Valley West High School. He detailed their relationship both on and off the mat and said that Justin demonstrated five traits: passion, confidence, resilience, vision, and courage (Attachment 3).

1SG Christopher Kyle Donaldson said he was honored to speak on behalf of 2LT Sisson. Lt. Sisson served as one of his Platoon Leaders in Able Company 1-506th, 101st Airborne Division. He felt that honoring our fallen soldiers by naming highways in their honor reminds those that see the road sign of the ultimate sacrifice that was given to protect our freedom (Attachment 4). After his presentation, Chairman Petersen thanked him for his service, on behalf of the Committee.
