- 1.) An estimated ten other states do have similar legislation requiring either legislative and/or committee over-site of this process.
- 2.) Details regarding time lines, milestones and any associated penalties are yet to be determined.
- 3.) Agencies would be allowed to work concurrently on their respective tasks. If committee did not approve any part of the plan it is assumed that the agencies would adjust plan to gain approval.

- 2.) Neither KDHE or KCC has the authority to propose a plan on building block number four.
- 3.) It is not understood how much influence state agencies might have should there be a need for a federal implementation plan (FIP).
