# <u>Hearing on: SB81 — Appropriation revisions and supplementals for FY 2015 and FY 2016 for various state agencies.</u>

Chairperson Masterson opened the hearing on <u>SB81</u>. J G Scott, Assistant Director for Fiscal Affairs, gave a summary overview of <u>SB81</u>, which is the revised Governor's rescission bill. He outlined the reductions and increases in expenditures from the State General Fund for FY2015. He explained the State General Fund Revenue Adjustments for the agencies per <u>SB81</u> (<u>Attachment 1</u>).

Mr Scott explained the pink sheets he distributed which were a breakdown of the adjustments by agency that were made by the Legislature and are now contained in **SB81** and **HB2133** (Attachment 2). He explained that the Governor has authority to make allotments and the amount of the Governor's allotment of \$60 million has already been removed and is not included in the bill.

After Mr Scott explained what was contained in <u>SB81</u>, he outlined some of the items that are not in the bill. He said there are some adjustments for school finance, such as capital outlay payments which were delayed until June 15, 2015, a \$34 million increase in the Local Option Budget, and an adjustment for the Kansas Bioscience Authority. Since the bill needs to be passed quickly, these items were not included, because they contain areas of controversy. Except for these K-12 items and the Kansas Bioscience Authority, the bill reflects the entire adjustments to the FY2015 Governor's Budget Recommendation

Mr Scott explained the State General Fund Profile, FY2013-FY2017. He said the State General Fund Profile figures were not in **SB81**; however, they will be in the mega bill (Attachment 3).
