Senator Denning, Chairperson of the Social Services Subcommittee, gave the Subcommittee Report for the Kansas Department of Health and Environment - Health and Health Care Finance (Attachment 3).

Senator Denning said the biggest part of KDHE is KanCare and Medicaid which encompasses

approximately 90% of KDHE's budget. He said approximately 35% is from SGF and 65% from other funds. He also said PERM, the eligibility system is going to move from DCF to KDHE at the beginning of next year.

Senator Denning reported the new Affordable Care Act (ACA) adds a \$20 million expense in the form of a tax each year. He said this tax goes through the MCO's and then to the IRS. He said the FMAP changes are large amounts of money that keep increasing because the federal government is paying less and Kansas is paying more. Senator Denning said in FY2016 the amount of the tax is \$24 million and in FY2017 it increases to \$30 million. He said in a two year period, we are paying \$50 million plus in annual expenses to our Medicaid program that has nothing to do with patient care, but are taxes and FMAP changes.

Senator Denning made a motion to add \$10 million to the budget, \$4,337,000 from SGF and the rest being the match to the Hepatitis C medications for the Medicare and Medicaid programs for FY2016 and FY2017. He said, if the money is not needed for Hepatitis C, it cannot be used for operational purposes, and it will lapse back to SGF. Senator Powell seconded the motion and the amendment passed on a voice vote.

Senator Denning made a motion to add language stating no state money will be appropriated for FY2015, FY2016, and FY2017 for new health home projects that are designated for the chronically ill without the express consent of the legislature. Senator O'Donnell seconded the motion.

Senator Francisco asked if these were the health homes the agencies were told would be in operation last July. Senator Denning said he did not know the answer to the question.

Susan Mosier, Acting Secretary of KDHE, said in the original launch they were scheduled to kick off in July, but were delayed, and there has not been a date re-set from the communications' office.

Senator Denning's motion to amend was recalled and the motion carried on a voice vote.

Senators Francisco and Kelly asked their "No" votes be recorded in the permanent record of the Ways and Means minutes.

Senator Denning made a motion to adopt the Subcommittee Report for the Kansas Department of Health and Environment - Health and Health Care Finance as amended for FY2015, FY2016 and FY2017. The motion was seconded by Senator Powell and the Subcommittee Report was adopted as amended on a voice vote.

Senator Denning explained to the committee that the Department for Aging and Disability Services handles all the waivers. He asked Amy Deckard, from Legislative Research, to distribute a spreadsheet with descriptions of all of the waivers. The title of the handout was "January 2015 HCBS Program Update" (Attachment 5).

Senator Denning made a motion to add \$382,000 from a proviso that has expired, and restore the funding of \$48,500 to SAC, a self advocate program, for FY2016 and FY2017, and reopen the guardianship program budget and restore \$46,493 to it. He said the balance of \$280,000 remains for Osawatomie State Hospital for their CMS structural improvement mandate. The motion was seconded by Senator Kelly.

Senator Kelly noted that on the SAC program where we are restoring \$48,500 from SGF, that same amount will be matched by Medicaid for a total of \$98,000.
