Senator Denning made a motion to reject on Page 1, the Department of Health and Environment Access Improvement Program, and non concur with GBA No 1, Item 7, on Page 3, Item No 1 for the Department of Revenue, and for the Department of Education, Page 3, Item, No 1 and to accept the House position on all of the other items that were addressed. Senator Arpke seconded the motion.

Senator Kelly asked if there was a printout showing the implication of rejecting the Department of Education item. Senator Masterson said there was no printout; however, the House did consider and accept the item; therefore it should be considered in conference committee for the mega budget. The motion was renewed and it carried on a voice vote.

Senator Francisco made a motion to add \$400,000 to the Department of Agriculture for the Water Office for the State Water Plan for FY2016 and FY2017 for streambank stabilization at Tuttle Creek Dam. Senator Kerschen seconded the motion and the motion passed on a voice vote.

J G Scott, Legislative Research, reported to the committee that all the other Governor's Budget

Mr Scott informed the committee that the revenue previously reported as collected from individual income tax was approximately \$81 million under estimate. He said the reason for the underestimation was due to the fact that 100,000 checks had not been deposited at the time the shortfall in revenue was reported. He said that these checks have now been deposited and revenue from income tax is approximately \$40 million over the amount collected last year. He reported further, that the estimated amount of income tax collections for this year was \$60 million, and it now appears, the estimate will be close to that amount.
