how the budget of each agency would be affected if the Governor's recommendations were adopted.

J. G. Scott, Assistant Director for Fiscal Affairs, explained **SB389** which includes the Governor's Budget Recommendations for FY2017. He also gave an overview of the State General Fund Revenue Adjustments as of Monday, February 1, 2016 ([Attachment 1](#)).

He then explained the Governor's Budget Recommendation 2017 Appropriations Supplemental Bill which reflects the Governor's Budget Recommendation Adjustments for FY2017 and FY2018 ([Attachment 2](#)).

Senator Francisco requested additional information concerning the expenditure for the Kansas Corporation Commission which is listed on Page 3 of the handout.

Senator Masterson asked Mr. Scott if the transfer of the funds from the Kansas Bioscience Authority to the State General Fund would require legislation, and he said yes, it would require a bill.

A report was distributed to the committee detailing revenues and expenditures accounted for and expended from the Emergency Management Revolving Fund by the six Regional Councils ([Attachment 3](#)).

The Chairperson closed the hearing on **SB389**.
