A handout entitled "Kansas Summary Recommendations, Prepared on 02/11/2016" was also distributed to the committee (Attachment 3).

Ms. Glynn reported that in January, 2016, they provided interim results of their review with identification of 105 items they recommended be implemented. She said the recommendations reflected an intense effort for three months undertaken by a team of 40 of Alvarez and Marsal professionals in collaboration with the State of Kansas employees at all levels, in order to gain a detailed understanding of the State's missions, programs, objectives and challenges. She said they would be focusing on Procurement and Risk Management and Insurance at today's meeting. She said they grouped the recommendations into three categories:

- Highest Value Category A recommendations;
- Transformational- Category B recommendations;
- Long Term Impact Category C recommendations.

J. W. Rust, Senior Director, Alvarez and Marsal, explained the Implementation Project Schedule on Page 6 of Attachment 1. He said they recommend each agency have a person to oversee the implementation of the recommendations for their particular agency. He stated, of the large number of items recommended, the implementation process could start immediately. Senator Kerschen said obviously someone will need to be in charge of the total implementation project. Mr. Rust said Shawn Sullivan would be overseeing the Statewide project.

Daniel Spragg, Managing Director, Insurance and Risk Advisory Services for Alvarez and Marsal, said their main focus is on risk management and how to control and cut losses. He said cost savings are generated by improved operating efficiency, alignment of risk with controls, strategic risk transfer and enhanced claims control and managing risk by establishing a DOA Office of Risk Management for oversight, including best practices to lower occurrences of worker's claims which would lower costs. He recommended a Statewide Insurance Procurement Program and he projected 10 percent savings with its successful implementation.

Senator Francisco voiced her concern with the recommendation of the large increase in the worker's comp rate to 1 percent on a 1 percent written premium basis.

Next on the agenda was Jerry Kavalieratos, Managing Director, Alvarez and Marsal, whose focus is on advising large organizations how to navigate major transformational efforts and Jefferson Howell, Director, Alvarez and Marsal of Houston, who advises private sector organizations on evaluating their procurement processes. They spoke to the committee in more detail concerning a central procurement process for all State agencies. They identified areas of possible savings by optimizing facility operations for reduction of energy usage, paying invoices in 30 days and negotiating early pay discounts, implementation of networking printers at universities and centralizing the management of wireless services.
