12 AN ACT concerning **reports, pamphlets, books and other printed**  
13 **materials; relating to** the division of accounts and reports; requiring  
14 certain reports to be provided; amending K.S.A. 46-925, **46-1212c**  
15 **and 75-3048** and repealing the existing section; also repealing K.S.A.  
16 75-6406.

17  
18 *Be it enacted by the Legislature of the State of Kansas:*

19 Section 1. K.S.A. 46-925 is hereby amended to read as follows: 46-  
20 925. Any payment made pursuant to this act shall be reported to the  
21 director of accounts and reports along with appropriate documentation  
22 ~~thereof of the payment~~ as may be required by such director. *Upon request*  
23 *of any legislator or, legislative committee or the legislative research*  
24 **department or other legislative staff agency**, the director of accounts  
25 and reports shall compile and maintain a report of all such payments and  
26 shall submit the same to the committee on ways and means of the senate  
27 and the committee on appropriations of the house of representatives and  
28 to the joint committee on special claims against the state at least 10 days  
29 prior to the convening of the regular session of the legislature *provide to*  
30 *such legislator or, committee or agency a report concerning all payments*  
31 *made pursuant to this act.*

32 **Sec. 2. K.S.A. 46-1212c is hereby amended to read as follows:**  
33 **46-1212c. (a) Any report, pamphlet, book or other materials re-**  
34 **quired to be submitted by a state agency to the legislature or the**  
35 **members thereof pursuant to K.S.A. ~~8-1201, 8-1760, 16a-6-104, 19-~~**  
36 **2674, 20-320, 20-2204, 22-3710, 25-4119a, 40-2309, 44-566a, 44-**  
37 **1004, 46-408, 50-628, 65-176, 65-4007, 72-6011, ~~72-6111, 72-6814,~~**  
38 **74-5503, ~~74-6203, 74-6706, 75-3048, 75-3302e, 75-5020, 75-5326, 75-~~**  
39 **5375, 79-1404, 79-1806 and 79-4301, and amendments to any of the**  
40 **foregoing sections thereto, in lieu of such submission, shall be sub-**  
41 **mitted to the director of legislative administrative services.**

42 (b) Notwithstanding the provisions of the sections enumerated in sub-  
43 section (a), if a state agency which publishes any such report, pamphlet,

1 book or other materials makes such report, pamphlet, book or other ma-  
2 terials available to the public on the internet as provided under K.S.A.  
3 75-3048 and amendments thereto, the state agency shall not be required  
4 to submit such report, pamphlet, book or other materials to the legislature  
5 or members thereof under the sections enumerated in subsection (a) or to  
6 the director of legislative administrative services under this section.

7 (c) **Upon submission of any such report, pamphlet, book or other**  
8 **materials to the director of legislative administrative services, the direc-**  
9 **tor shall compile and maintain a current listing thereof and shall**  
10 **make such listing available at least monthly to each member of the**  
11 **legislature by electronic mail. The director, upon request made there-**  
12 **for by any member of the legislature, shall make available any such**  
13 **report, pamphlet, book or other materials enumerated on such list-**  
14 **ing to such requesting member.**

15 **Sec. 3. K.S.A. 75-3048 is hereby amended to read as follows:**  
16 **75-3048. (a) Each state agency may have printed such reports, pam-**  
17 **phlets, books and material as pertain to its activity and which are**  
18 **within the terms of a specific legislative authorization or appropri-**  
19 **ation except that a state agency which makes such reports, pamphlets,**  
20 **books or material available to the public on the internet for a period of**  
21 **at least six months following the publication of such material is not re-**  
22 **quired to print copies of such reports, pamphlets, books or material so**  
23 **long as the state agency retains an electronic copy of such report, pam-**  
24 **phlet, book or material in the archives of the agency for historical pur-**  
25 **poses. If a state agency is required by law to provide a report, pamphlet,**  
26 **book or other material to another state agency or state official and the**  
27 **state agency makes such report, pamphlet, book or other material avail-**  
28 **able to the public on the internet for a period of at least six months fol-**  
29 **lowing the publication of such material, in lieu of providing such report,**  
30 **pamphlet, book or other material the state agency may notify such other**  
31 **state agency or state official that the report, pamphlet, book or other**  
32 **material is available on the internet by electronic mail.**

33 (b) **If copies are printed by the state agency, printed copies shall be**  
34 **delivered to the governor, state librarian, the secretary of the state**  
35 **historical society and the secretary of the legislative coordinating coun-**  
36 **cil and a copy shall be mailed or delivered to each member of the**  
37 **legislature. Printed copies of such publication shall be sold at ap-**  
38 **proximately the cost of printing the same and the amount received**  
39 **therefrom shall be placed in the state treasury and credited to the**  
40 **fee fund of such agency, if it has a fee fund, and if not, to the general**  
41 **fund of the state except that research, industrial, agricultural and**  
42 **educational matter of general concern to the people of Kansas may**  
43 **be distributed without charge.**

1     Sec. ~~2~~ **4**. K.S.A. 46-925, **46-1212c**, **75-3048** and 75-6406 are  
2 hereby repealed.

3     Sec. ~~3~~ **5**. This act shall take effect and be in force from and after its  
4 publication in the statute book.
