9 AN ACT concerning the Kansas dental board; regarding permit fee;  
10 amending K.S.A. 2006 Supp. 65-1447 and repealing the existing  
11 section.

13 *Be it enacted by the Legislature of the State of Kansas:*

14 Section 1. K.S.A. 2006 Supp. 65-1447 is hereby amended to read as  
15 follows: 65-1447. (a) On or before October 1 of each year, the Kansas  
16 dental board shall determine the amount of funds which will be required  
17 during the ensuing fiscal year to properly administer the laws which the  
18 board is directed to enforce and administer and shall fix fees in accord-  
19 ance with this section in such reasonable sums as may be necessary for  
20 such purposes, within the limitations prescribed by subsection (b).

21 (b) The board shall collect fees provided for in this act as follows:

42 (c) The amounts of fees in effect on the day preceding the effective  
43 date of this act and the act of which this section is amendatory shall remain

1 in effect until fixed in different amounts by the board under this section.  
2 The board may adopt rules and regulations for the proration of fees for  
3 a license issued for a period of time less than the biennial licensure period.  
4 Sec. 2. K.S.A. 2006 Supp. 65-1447 is hereby repealed.  
5 Sec. 3. This act shall take effect and be in force from and after its  
6 publication in the statute book.
