10 AN ACT concerning libraries **certain political and taxing subdivi-**  
11 **sions**; amending K.S.A. 12-1232 and repealing the existing section.

13 *Be it enacted by the Legislature of the State of Kansas:*

14 Section 1. K.S.A. 12-1232 is hereby amended to read as follows: 12-  
15 1232. The library board of a regional library shall consist of six ~~(6)~~ ap-  
16 pointed members and, in addition thereto, the official head of each par-  
17 ticipating county or township shall *appoint a member of the governing*  
18 *body* to be an ex officio member with the same powers as appointed  
19 members. Each county or township participating in a regional library shall  
20 be equally represented on the library board, but in case such uniform  
21 representation cannot be obtained because of the number of counties or  
22 townships participating, the governing body shall agree on a method of  
23 rotating representation among the participating counties or townships.  
24 The official head of each participating county or township, with the ap-  
25 proval of the governing body thereof, shall appoint the members from  
26 such county or township.

27 Terms of all members of the library board of any township library  
28 previously established under the authority of K.S.A. 80-804 shall expire  
29 on the effective date of this act and successors to such members shall be  
30 appointed in the manner and for the terms prescribed in this section.

31 The members first appointed shall be appointed, one ~~(1)~~ for a term  
32 expiring the first April 30th following date of appointment, two ~~(2)~~ for  
33 terms expiring the second April 30th following date of appointment, one  
34 ~~(1)~~ for a term expiring the third April 30th following date of appointment,  
35 and two ~~(2)~~ for terms expiring the fourth April 30th following date of  
36 appointment. Upon the expiration of the terms of members first ap-  
37 pointed, succeeding members shall be appointed in like manner for terms  
38 of four ~~(4)~~ years. Vacancies occasioned by removal from the county or  
39 township, resignation or otherwise, shall be filled by appointment for the  
40 unexpired term. Except for the ex officio members of the board, no per-  
41 son holding any office in a participating county or township shall be a  
42 member of the library board while holding such office, and no person  
43 who has been appointed for two ~~(2)~~ four-year terms to the library board

1 shall be eligible for further appointment to such board.  
2 **New Sec. 2. The board of directors of drainage district No. 2**  
3 **of Finney county shall provide by the passage of a resolution for**  
4 **the staggering of terms of the board. At the next election of direc-**  
5 **tors, one director shall be elected for a two-year term and two**  
6 **directors shall be elected for three-year terms. Election of direc-**  
7 **tors thereafter shall be for three-year terms.**  
8 Sec. ~~2~~ 3. K.S.A. 12-1232 is hereby repealed.  
9 Sec. ~~3~~ 4. This act shall take effect and be in force from and after its  
10 publication in the statute book.
