

## SENATE BILL No. 361

9 AN ACT concerning athletic events; relating to the Kansas sports hall of  
10 fame; relating to funding thereof; concerning postsecondary education  
11 institutions; relating to the funding of deferred maintenance.  
12

13 *Be it enacted by the Legislature of the State of Kansas:*

14 Section 1. The Kansas state high school activities association shall  
15 collect \$.50 in addition to the admission price paid by each paying atten-  
16 dee at high school state football championship games and to men's and  
17 women's sports championship tournaments. The governing body of the  
18 Kansas state high school activities association shall collect and disburse  
19 the moneys collected to the state of Kansas sports hall of fame board of  
20 trustees on a monthly basis.

21 Sec. 2. (a) Each university shall collect \$2 in addition to the admis-  
22 sion price paid by each paying attendee at every intercollegiate athletic  
23 event to assist in the funding of projects for rehabilitation, maintenance  
24 and repairs of buildings and facilities of such university.

25 (b) Each community college shall collect \$1 in addition to the ad-  
26 mission price paid by each paying attendee at every intercollegiate athletic  
27 event to assist in the funding of projects for rehabilitation, maintenance  
28 and repairs of buildings and facilities of such community college.

29 (c) A "paying attendee" means any person who gives monetary con-  
30 sideration, regardless of the amount, for admission to an athletic event,  
31 including single game tickets, season tickets and student tickets, but not  
32 including student activity tickets which allow admission to non-athletic  
33 events as well as athletic events.

34 (d) The moneys collected pursuant to subsection (a) shall be depos-  
35 ited in the state treasury and credited to the deferred maintenance sup-  
36 port fund of the university which collected such moneys. The moneys  
37 collected pursuant to subsection (b) shall be deposited in the state treas-  
38 ury and credited to the community colleges deferred maintenance sup-  
39 port fund which is hereby created. The community colleges deferred  
40 maintenance support fund shall be administered by the state board of  
41 regents. All expenditures from the community colleges deferred main-  
42 tenance support fund shall be made in accordance with appropriation acts  
43 upon warrants of the director of accounts and reports issued pursuant to

1 vouchers approved by the state board of regents or by a person or persons  
2 designated by the state board of regents. The moneys credited to the  
3 fund shall be used for the funding of projects for rehabilitation, mainte-  
4 nance and repairs of buildings and facilities of the community college  
5 which collected such moneys.

6 (e) As used in this section:

7 (1) "Community college" shall have the meaning ascribed thereto by  
8 K.S.A. 74-3201b, and amendments thereto.

9 (2) "University" means Emporia state university, Fort Hays state uni-  
10 versity, university of Kansas, Kansas state university, Pittsburg state uni-  
11 versity, Wichita state university and Washburn university.

12 Sec. 3. This act shall take effect and be in force from and after its  
13 publication in the statute book.
