10 AN ACT concerning school districts; relating to school finance; amend-
11 ing K.S.A. 2007 Supp. 72-6448 and repealing the existing section.
12

13 *Be it enacted by the Legislature of the State of Kansas:*

14 Section 1. K.S.A. 2007 Supp. 72-6448 is hereby amended to read as
15 follows: 72-6448. (a) (1) *As used in this subsection, "pupil" shall have the*
16 *meaning ascribed thereto in K.S.A. 72-6407, and amendments thereto.*

17 (2) *If the number of pupils enrolled in a district on February 20, of*
18 *each school year has increased from the number of pupils enrolled in the*
19 *district on the preceding September 20, by ~~at least 25 pupils or by a~~*
20 *number equal to 1% or more of the district's enrollment, the enrollment*
21 *of the district for such school year shall be determined on February 20.*

22 (3) *The state board shall compute the general fund budget of a school*
23 *district as follows:*

24 (A) *Compute the general fund budget of the district using the enroll-*
25 *ment of the district on February 20 of each school year;*

26 (B) *compute the general fund budget of the district using the enroll-*
27 *ment of the district on the preceding September 20 of such school year;*

28 (C) *subtract the amount determined under paragraph (B) from the*
29 *amount determined under paragraph (A);*

30 (D) *multiply the difference obtained under paragraph (C) by .50; and*

31 (E) *add the product obtained under paragraph (D) to the amount*
32 *determined under paragraph (B). The sum is the general fund budget of*
33 *the school district.*

34 (4) ~~*This section shall be subject to the provisions of subsection (b).*~~

35 ***[The provisions of this subsection shall take effect and be in force***
36 ***from and after July 1, 2009.]***

37 (b) (1) ~~As used in this section~~ *subsection, "pupil" means a person*
38 *who is a dependent of a full-time active duty member of the military*
39 *service or a dependent of a member of any of the United States military*
40 *reserve forces who has been ordered to active duty under section 12301,*
41 *12302 or 12304 of Title 10 of the United States Code, or ordered to full-*
42 *time active duty for a period of more than 30 consecutive days under*
43 *section 502(f) or 512 of Title 32 of the United States Code for the pur-*

1 poses of mobilizing for war, international peacekeeping missions, national
2 emergency or homeland defense activities.

3 ~~(b) If the number of pupils enrolled in a district on February 20,~~

19 shall submit any documentation or information required by the state

21 *(d) The provisions of this section shall be subject to the appropriation*
22 *of moneys for general state aid which are in addition to the amount of*
23 *moneys appropriated for general state aid for fiscal year 2008.*
