9 AN ACT concerning the state board of regents; relating to the Kansas
10 academy for math and science; making and concerning appropriations
11 for the fiscal years ending June 30, 2009, June 30, 2010, June 30, 2011,
12 June 30, 2012, June 30, 2013, June 30, 2014, and June 30, 2015.

14 *Be it enacted by the Legislature of the State of Kansas:*

15 Section 1. (a) For the fiscal years ending June 30, 2009, June 30, 2010,
16 June 30, 2011, June 30, 2012, June 30, 2013, June 30, 2014, and June 30,
17 2015, appropriations are hereby made, restrictions and limitations are
18 hereby imposed, and transfers, capital improvement projects, fees, re-
19 cepts, disbursements and acts incidental to the foregoing are hereby di-
20 rected or authorized as provided in this act.

21 (b) This act shall not be subject to the provisions of subsection (a) of
22 K.S.A. 75-6702 and amendments thereto.

23 (c) The appropriations made by this act shall not be subject to the
24 provisions of K.S.A. 46- 155 and amendments thereto.

32	<i>Provided</i> , That any unencumbered balance in the Kansas academy for	
33	math and science account in excess of \$100 as of June 30, 2009, is hereby	
34	reappropriated for fiscal year 2010.	
35	For the fiscal year ending June 30, 2011.....	\$754,000
36	<i>Provided</i> , That any unencumbered balance in the Kansas academy for	
37	math and science account in excess of \$100 as of June 30, 2010, is hereby	
38	reappropriated for fiscal year 2011.	
39	For the fiscal year ending June 30, 2012.....	\$792,000
40	<i>Provided</i> , That any unencumbered balance in the Kansas academy for	
41	math and science account in excess of \$100 as of June 30, 2011, is hereby	
42	reappropriated for fiscal year 2012.	
43	For the fiscal year ending June 30, 2013.....	\$835,000

1 *Provided*, That any unencumbered balance in the Kansas academy for
2 math and science account in excess of \$100 as of June 30, 2012, is hereby
3 reappropriated for fiscal year 2013.

4 For the fiscal year ending June 30, 2014 \$938,000

5 *Provided*, That any unencumbered balance in the Kansas academy for
6 math and science account in excess of \$100 as of June 30, 2013, is hereby
7 reappropriated for fiscal year 2014.

8 Any unencumbered balance in the Kansas academy for math and science
9 account in excess of \$100 as of June 30, 2014, is hereby reappropriated
10 for fiscal year 2015.
