#### MOTIONS TO CONCUR AND NONCONCUR

On motion of Rep. Mays, the House nonconcurrred in Senate amendments to **HB 2038** and asked for a conference.

Speaker Glasscock thereupon appointed Reps. Mays, Hutchins and Rehorn as conferees on the part of the House.

#### COMMITTEE OF THE WHOLE

On motion of Rep. Kuether, Committee of the Whole report, as follows, was adopted:

Recommended that **HB 2119**, **HB 2009** be passed.

#### REPORTS OF STANDING COMMITTEES

The Committee on **Agriculture** recommends **HB 2103** be amended on page 4, after line 2, by inserting the following:

"Sec. 3. K.S.A. 2000 Supp. 75-4272 is hereby amended to read as follows: 75-4272. (a) The state treasurer may accept or reject an agricultural production loan deposit loan package based on the state treasurer's evaluation of whether the loan to the eligible agricultural borrower meets the purposes of this act. If sufficient funds are not available for an agricultural production loan deposit, then the applications may be considered in the order received when funds are once again available subject to a review by the lending institution.

(b) Upon acceptance, the state treasurer shall certify to the director of investments the amount required for such agricultural production loan deposit loan package and the director

of investments shall place an agricultural production loan deposit in the amount certified by the state treasurer with the eligible lending institution at an interest rate, which is 2% below the market rate provided in K.S.A. 75-4237, and amendments thereto, and which shall be recalculated on the first business day of *January and July* of each ~~calendar~~ year using the market rate then in effect. When necessary, the state treasurer may request the director of investments to place such agricultural production loan deposit prior to acceptance of an agricultural production loan deposit loan package.

(c) The eligible lending institution shall enter into an agricultural production loan deposit agreement with the state treasurer, which shall include requirements necessary to implement the purposes of the Kansas agricultural production loan deposit program. Such requirements shall include an agreement by the eligible lending institution to lend an amount equal to the agricultural production loan deposit to eligible agricultural borrowers at an interest rate which is not more than 2% above the market rate as determined under K.S.A. 75-4237, and amendments thereto, and which shall be recalculated on the first business day of *January and July* of each ~~calendar~~ year using the market rate then in effect. The agreement shall include provisions for the agricultural production loan deposit to be placed for a maturity considered appropriate in coordination with the underlying agricultural production loan. The agreement shall include provisions for the reduction of the agricultural production loan deposit in an amount equal to any payment of loan principal by the eligible agricultural borrower.”;

And by renumbering sections accordingly;

Also on page 4, in line 3, by striking “and” and inserting a comma; also in line 3, after “75-4271” by inserting “and 75-4272”;

On page 1, in the title, in line 10, by striking “and” the first time it appears and inserting a comma; also in line 10, after “75-4271” by inserting “and 75-4272”; and the bill be passed as amended.

The Committee on **Business, Commerce and Labor** recommends **HB 2300, HB 2301, HB 2303, HB 2304** be passed and, because the committee is of the opinion that the bills are of a noncontroversial nature, be placed on the consent calendar.

The Committee on **Environment** recommends **HB 2200, HB 2317** be passed.

The Committee on **Environment** recommends **HB 2134** be amended on page 7, in line 12, by striking all following “(i)”;

in line 13, by striking all preceding “permit” and inserting “(1) Permits granted by the secretary as provided by this act shall not be transferable except as follows:

(A) A”;

Also on page 7, in line 14, by striking all following “if” and inserting “the”; in line 17, by striking “; and (B)” and inserting “and”; in line 19, by striking “; and (2)” and inserting a period; also in line 19, preceding “shall” by inserting a new paragraph as follows:

“(B) A permit for a solid waste disposal area or a solid waste processing facility may be transferred if the secretary approves of the transfer based upon information submitted to the secretary sufficient to conduct a background investigation of the new owner as specified in subsections (c) and (d) of K.S.A. 65-3407, and amendments thereto, and a financial assurance evaluation as specified in subsection (h) of K.S.A. 65-3407, and amendments thereto. Such information shall be submitted to the secretary not more than one year nor less than 60 days before the transfer. If the secretary does not approve or disapprove the transfer within 30 days after all required information is submitted to the secretary, the transfer shall be deemed to have been approved.

(2) Permits granted by the secretary as provided by this act”;

Also on page 7, in line 26, preceding “The” by inserting a new paragraph as follows:

“(3)”;

Also on page 7, following line 31, by inserting the following:

“(j) Except as otherwise provided by subsection (i)(1), the secretary may require a new permit application to be submitted for a solid waste processing facility or a solid waste disposal area in response to any change, either directly or indirectly, in ownership or control of the permitted real property or the existing permittee.”;

By relettering the remaining subsections accordingly;

On page 11, by striking all in lines 16 through 19 and inserting the following:

“(8) Divide a solid waste disposal area which has been issued a permit pursuant to K.S.A. 65-3407, and amendments thereto, into two or more parcels of real property for the purpose of selling or transferring a portion of the permitted area to a new owner without receiving prior approval of the secretary. If the secretary does not approve the division of the area within 60 days after the matter is submitted to the secretary for approval, the division shall be deemed to have been approved. Approval pursuant to this subsection shall not be necessary for transfer of a permitted solid waste disposal area as allowed by subsection (i)(1) of K.S.A. 65-3407, and amendments thereto.”;

On page 13, in line 12, following “authority” by inserting “, college, university, school, state agency”; in line 15, following “authority” by inserting “, college, university, school, state agency”; in line 33, by striking all following “contributions”; in line 34, by striking all preceding the period; and the bill be passed as amended.
