SENATE CHAMBER, TOPEKA, KANSAS
Tuesday, February 27, 2001—2:30 p.m.

The Senate was called to order by President Dave Kerr.

The roll was called with thirty-nine senators present.

Senator Huelskamp was excused.

President Kerr introduced as guest chaplain, Rev. Delmar White, Antioch Missionary Baptist Church, Topeka, Kansas, who delivered the invocation:
