The House met Session pro forma pursuant to adjournment with Assistant Majority Leader Ballou in the chair.

INTRODUCTION OF BILLS AND CONCURRENT RESOLUTIONS

The following bills were introduced and read by title:

HB 2812, An act amending the uniform consumer credit code; relating to balloon payments; amending K.S.A. 16a-3-308 and repealing the existing section, by Committee on Financial Institutions.

HB 2813, An act concerning real estate sales validation questionnaires; concerning use of contents; amending K.S.A. 2001 Supp. 79-1437f and repealing the existing section, by Committee on Financial Institutions.

HB 2814, An act concerning health care providers; relating to compensation and peer review thereof; amending K.S.A. 44-510h and K.S.A. 2001 Supp. 44-508 and repealing the existing sections, by Committee on Business, Commerce and Labor.

HB 2815, An act concerning certain noise from oil and gas wells; prohibiting certain acts and providing penalties and civil remedies for violations, by Representative McCreary.

HB 2816, An act repealing K.S.A. 2001 Supp. 58-3221 through 58-3225; relating to sport shooting ranges, by Representatives Ray and Huff.

HB 2817, An act concerning agricultural liens; relating to filing requirements; amending K.S.A. 58-204 and repealing the existing section, by Committee on Agriculture.

HB 2818, An act concerning agriculture; creating the sunflower commodity commission; prescribing certain powers, duties and responsibilities; assessments; amending K.S.A. 2-3001, 2-3002, 2-3003, 2-3006 and 2-3007 and repealing the existing sections, by Committee on Agriculture.

HB 2819, An act concerning abortion clinics; standards for the operation thereof; providing penalties for violations and authorizing injunctive actions, by Representatives P. Long, Cook, Dahl, DeCastro, Faber, Howell, Huebert, Hutchins, Huy, Kauffman, Landwehr, Lloyd, Mason, Mays, McClure, McCreary, Merrick, Miller, Judy Morrison, Myers, Osborne, Ostneyer, Pauls, L. Powell, T. Powell, Thimesch, Toplikar, Vickrey and D. Williams.

REPORTS OF STANDING COMMITTEES

The Committee on **Environment** recommends **HB 2680** be passed.

The Committee on **Environment** recommends **HB 2624** be amended on page 2, by striking all in lines 15 through 19 and renumbering subsections (9) through (13) accordingly; in line 21, by striking "construction, installation,;" also in line 21, following "of" by inserting "state-permitted"; in line 24, by striking all following "agencies"; by striking all in lines 25 through 27; in line 28, by striking all preceding the semicolon;

On page 3, in line 29, by striking "construct, install," and inserting "contract with cities or counties, or both, to"; also in line 29, following "maintain" by inserting "state-permitted"; in line 31, by striking "and outside"; and the bill be passed as amended.

The Committee on **Transportation** recommends **HB 2663** be passed.

The Committee on **Utilities** recommends **HB 2635** be amended on page 1, in line 14, following "all" by inserting "substations,;" also in line 14, by striking "necessary ap-"; in line 15, by striking all preceding "for" and inserting "structures and equipment necessary"; in line 25, by striking all following "appurtenances"; in line 26, by striking all preceding "115" and inserting "to be used for the transfer of"; in line 27, by striking "having"; in line 28, by striking all preceding "115" and inserting "to be used for the transfer of"; in line 30, by striking "to have the capacity to transfer" and inserting "to be used for the transfer of"; and the bill be passed as amended.

(Having been referred separately, **HB 2635** is now in Committee on **Appropriations**.)
