EXPLANATIONS OF VOTE

MR. SPEAKER: I vote no on **HB 2767**. It is bad for agriculture. It regulates oral and written agricultural contracts which will place our farmers and ranchers at a competitive disadvantage for building production alliances. It opens the door for litigation against entrepreneurs who seek profit in a competitive marketplace. It brings agricultural production contracts into the consumer protection act, converting an agricultural production contract into a consumer transaction and regulates it.

Every time government creates "special" rules making doing business in agriculture more difficult than in other sectors of the economy, disincentives for further investment in rural enterprises are created.—DAN JOHNSON, GARY HAYZLETT, STANLEY DREHER, DON DAHL, LLOYD STONE, LARRY CAMPBELL

MR. SPEAKER: Kansas residents are watching how each and every one of us votes today on **HB 2767**. Just because you voted for the "No Call" amendment on this legislation doesn't get you off the hook if you vote no on this bill.

So think about this. The next time one of your constituents is bothered at dinner time with yet another annoying telemarketer, that voter will think of you and remember if you voted yes or no on **HB 2767**. You can believe, I vote yes on **HB 2767**.—L. CANDY RUFF

MR. SPEAKER: I vote no on **HB 2767** because I think the amendment regarding production contracts is not a good amendment. If I sold some cattle to a feedyard and through no fault of mine some of the cattle died the feedyard could possibly go to the attorney general and they could go after me for delivering faulty merchandise. I don't think this is good for small farmers when you have the attorney general representing large feedyards going after people who are trying to make a living on the farm.—LARRY POWELL

MR. SPEAKER: Last Friday when **HB 2767** was considered two amendments were passed. These amendments have not had committee consideration. I question that few of you understood the far reaching consequences to the industries affected as well as the cost to the State of Kansas and to the taxpayer of Kansas. I vote no on **HB 2767**.—SHARON SCHWARTZ

MR. SPEAKER: I support the underlying bill. I support no-call legislation. But, the amendment of **HB 2767** to classify ag commodity contracts as consumer transactions subject to the Consumer Protection Act is a public policy road this body does not want to travel. Trial lawyers have too much to do as it is, and need no additional civil remedies.

The CPA is designed to protect those who by virtue of their ignorance, illiteracy or inability to understand the language of contracts they voluntarily enter into, and I will not by my vote brand Kansas farmers ignorant, illiterate, or incapable of knowledgeable decisions.—WARD LOYD, MELVIN J. MR. SPEAKER: I vote "No" on **HB 2767**. Several weeks ago I filed a form with my local telephone company which placed my name on a "no-call" list for telemarketers. That same

service is available for you or your constituents, and we do not need to confuse a consumer protection act by amending a no-call telephone measure into it. Thank you!—RALPH M. TANNER

MR. SPEAKER: Our vote today on **HB 2767** carried untold consequences.

We are voting on policy that was hastily added in a floor amendment. We have not seen a fiscal note, though we know there is a cost. There has not been adequate opportunity for public input, though we know there are opponents. We cannot be sure this bill is the best option for the people of Kansas.

I support the concept on a "no-call list," but I also support the legislative process. Mr. Speaker, I vote "No" on **HB 2767** to give both principles a chance.—KENNY WILK

MR. SPEAKER: Neither of the amendments placed on **HB 2767** have followed established committee procedures although separately they are ideas that, in my opinion, should go forward. Besides my concern regarding circumvention of the committee process, I am concerned that the agricultural contractual amendment uses language that will be difficult to interpret and may be confusing to those who need its protection. Hopefully, this portion of the bill will be reworded to clarify language so opposing groups can work toward a compromise to ensure protection for all producers. **HB 2767** as amended may have unintended consequences; therefore, I must vote no.—DEENA HORST

MR. SPEAKER: I strongly support the concept of a no-call list to protect the people of Kansas from unwelcome calls and solicitations. I could not support **HB 2767** as amended. One of the amendments added to this bill would hurt farmers and the agricultural industry that is a backbone of our state's economy. By increasing the government's obligations to patrol agriculture contractors, this puts an unknown, but certainly great fiscal burden on the state at a time we are struggling to fund social services for our most vulnerable citizens. REPORTS OF STANDING COMMITTEES

The Committee on **Education** recommends **HB 2844** be passed.

The Committee on **Education** recommends **HB 2353** be amended on page 1, in line 14, by striking "class" and inserting "program"; also in line 14, by striking "given in" and inserting "offered to"; in line 16, by striking "during the school day";

In the title, in line 10, by striking "class" and inserting "program"; and the bill be passed as amended.

The Committee on **Health and Human Services** recommends **HB 2285** be amended by substituting a new bill to be designated as "Substitute for HOUSE BILL No. 2285," as follows:

"Substitute for HOUSE BILL No. 2285

By Committee on Health and Human Services

"AN ACT concerning optometry; relating to contact lens; amending K.S.A. 65-1504b and repealing the existing section.";

and the substitute bill be passed.

(**Sub. HB 2285** was thereupon introduced and read by title.)

The Committee on **Health and Human Services** recommends **HB 2372** be amended on page 1, after line 12, by inserting the following:

"Section 1. K.S.A. 2001 Supp. 65-6406 is hereby amended to read as follows: 65-6406. The board shall issue a license to an individual who is currently registered, certified or licensed to practice marriage and family therapy in another jurisdiction if the board determines that the standards for registration, certification or licensure to practice marriage and family therapy in the other jurisdiction are ~~at least equivalent to or exceed~~ *substantially the equivalent of* the requirements of the marriage and family therapists licensure act and rules and regulations of the board. An applicant for a license under this section shall pay an application fee established by the board under K.S.A. 65-6411 and amendments thereto.

Sec. 2. K.S.A. 2001 Supp. 74-5310 is hereby amended to read as follows: 74-5310. (a) The board shall issue a license as a psychologist to any person who pays an application fee

prescribed by the board, not in excess of \$150 and an original license fee not in excess of \$200, which shall not be refunded, who either satisfies the board as to such person's training and experience after a thorough review of such person's credentials ~~or~~ and who passes a satisfactory examination in psychology. Any person paying the fee must also submit evidence verified by oath and satisfactory to the board that such person: (1) Is at least 21 years of age; (2) is of good moral character; (3) has received the doctor's degree based on a program of studies in content primarily psychological from an educational institution having a graduate program with standards consistent with those of the state universities of Kansas, or the substantial equivalent of such program in both subject matter and extent of training; and (4) has had at least two years of supervised experience, a significant portion of which shall have been spent in rendering psychological services satisfying the board's approved standards for the psychological service concerned.

(b) The board shall adopt rules and regulations establishing the criteria which an educational institution shall satisfy in meeting the requirements established under item (3) of subsection (a). The board may send a questionnaire developed by the board to any educational institution for which the board does not have sufficient information to determine whether the educational institution meets the requirements of item (3) of subsection (a) and rules and regulations adopted under this section. The questionnaire providing the necessary information shall be completed and returned to the board in order for the educational institution to be considered for approval. The board may contract with investigative agencies, commissions or consultants to assist the board in obtaining information about educational institutions. In entering such contracts the authority to approve educational institutions shall remain solely with the board.”;

By striking all in lines 13 through 28;

Also on page 1, preceding line 29, by inserting the following:

“Sec. 3. K.S.A. 2001 Supp. 65-6406 and 74-5310 are hereby repealed.”;

And by renumbering the remaining section accordingly;

In the title, in line 9, after “ACT” by inserting “concerning the board of behavioral sciences; marriage and family therapists and psychologists; amending K.S.A. 2001 Supp. 65-6406 and 74-5310 and repealing the existing sections”; also in line 9, by striking “providing for the certification of behavior analysts; duties and”; in line 10, by striking all before the period; and the bill be passed as amended.

The Committee on **Health and Human Services** recommends **HB 2744** be amended on page 1, in line 15, after “physician” by inserting “, a licensed physician assistant, who has been specially trained in performing sexual assault evidence collection,”; in line 24, after “physician” by inserting “, licensed physician assistant”; in line 27, after “physician” by inserting “, licensed physician assistant”; in line 28, after “physician” by inserting “, licensed physician assistant”; and the bill be passed as amended.

The Committee on **Utilities** recommends **HB 2959** be passed.

A RESOLUTION in memory of Lloyd Polson.

WHEREAS, Lloyd Dale Polson, a Vermillion farmer and former representative from districts number 61 and later 62, died February 11, 2002, at age 73. A Republican, he served four terms in the Kansas House of Representatives from 1979 to 1986 and was Chairperson of the House Agriculture Committee his last term; and

WHEREAS, Lloyd Polson was a former Marshall County GOP Chairman and was active in many candidates' campaigns. Described as a kind and fine gentleman, he was also a man of strong convictions who advised political candidates they should "tell people where you're going to stand and then stand there"; and

WHEREAS, Lloyd Polson was considered a member of the president's inner circle during President Reagan's administration. He traveled to Washington, D.C. to meet with the President and with Secretary of Defense Cooper Weinberger and Alan Greenspan. He attended Mr. Reagan's inauguration and Republican national conventions in San Diego and Detroit; and

WHEREAS, Lloyd Polson was a member of an agricultural delegation of Americans who traveled to Romania to meet with government officials and advise them on agricultural policies; and

WHEREAS, Lloyd Polson always loved the land and spent a lot of time walking his fields to check the crops. He liked to fish and hunt and was an avid rock collector, especially agate and Indian artifacts, and enjoyed attending rock and gem shows throughout the country; and

WHEREAS, Lloyd Polson was a member of Unified School District number 488 board of directors for 10 years, a member of the Nemaha County Hospital board, the Kansas State Soybean Producers board of directors, the National Board of Lutheran for Life and a lifetime member of the Salem Lutheran Church in Axtell; and

WHEREAS, Lloyd Polson graduated from Centralia High School in 1946 and earned a degree in agricultural economics from Kansas State University in 1956. He married Delores Swanson on July 15, 1952; she survives his death. Also surviving are a son, Craig Polson; two daughters, Susan Brown and Patricia Anenson; and 10 grandchildren; Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we recognize the civic service Lloyd Polson has given to his state and community and extend our deepest sympathy to his family; and
