SENATE CHAMBER, TOPEKA, KANSAS
Monday, May 13, 2002—11:00 a.m.

The Senate was called to order by President Dave Kerr.

Invocation by Chaplain Fred S. Hollomon:

Heavenly Father,

While I do not minimize the gravity of our state's financial crisis, it usually helps to keep things in perspective. While we have been in session the past week, several tragic events have taken place in the world:

In Mexico City twenty men opened fire on a Mothers Day party, killing eleven people and injuring eight others.

In the Bahamas an overloaded sloop capsized and twelve migrants drowned and fifteen are missing.

In England a high speed train derailed, killing seven people and seriously injuring nine.

In Illinois a violent wind storm killed two people and injured more than a dozen others.

Two Navy jets crashed in the Gulf of Mexico during a training mission and the seven crew members are missing.

In Nigeria an airliner crashed and 145 were reported dead with the number likely to rise.

And just yesterday here in Topeka four young children were left fatherless when their minivan collided with a deer. Their mother was seriously injured.

Help us, O God, to back off and view our predicament against the backdrop of nine-eleven, the Mideast crisis, and the many other tragedies occurring constantly all over the world. Perhaps it will help us to deal with our own crisis even more calmly and rationally and with more reliance on Your wisdom.
