"AN ACT concerning workers compensation; relating to date of accident; amending K.S.A. 2004 Supp. 44-508 and repealing the existing section."; and the substitute bill be passed.

"(13) as provided by section 9, and amendments thereto, incurring or assuming indebtedness and entering into contracts with the Kansas development finance authority, which is authorized to borrow money, issue bonds and provide financing for: (A) The construction, upgrading or repair of transmission facilities of the Kansas electric transmission authority or the acquisition of right-of-way for such facilities, or both, and any such bonds shall be payable from and be secured by the pledge of revenues derived from the operation of such electric transmission facilities; or (B) making loans to finance the construction, upgrading or repair of transmission facilities not owned by the Kansas electric transmission authority or the acquisition of right-of-way for such facilities, or both, upon such terms and conditions as required by the authority, including a requirement that any entity receiving a loan under this act shall maintain records and accounts relating to receipt and disbursements of loan proceeds, transportation costs and information on energy sales and deliveries and make the records available to the authority for inspection, and any such bonds shall be payable from and be secured by the pledge of revenues derived from the operation of such electric transmission facilities;";

Also on page 5, in line 21, by striking "(15)" and inserting "(14)"; in line 26, by striking "(16)" and inserting "(15)"; in line 28, by striking "Kansas"; by striking all in lines 29 through 36 and inserting "all electric public utilities, electric municipal utilities and electric cooperative utilities receiving benefits of the construction or upgrade and having retail customers in this state. Each such utility's assessment shall be based on the benefits the utility receives from the construction or upgrade, as determined by the state corporation commission upon application by the authority. In determining allocation of benefits and costs to utilities, the commission may take into account funding and cost recovery mechanisms developed by regional transmission organizations and shall take into account financial payments by transmission users and approved by the federal energy regulatory commission or regional transmission organization. Each electric public utility shall recover any such assessed costs from the utility's retail customers in a manner approved by the commission and each electric municipal or cooperative utility shall recover such assessed costs from the utility's retail customers in a manner approved by the utility's governing body;"; in line 37, by striking "(17)" and inserting "(16)"; in line 43, by striking "(18)" and inserting "(17)";

On page 6, in line 4, by striking "(19)" and inserting "(18)";

On page 7, in line 26, by striking "New";

On page 8, in line 4, by striking "New";

On page 9, in line 1, by striking "New"; in line 21, by striking "New"; in line 29, by striking "New"; in line 43, by striking "New";

In the title, in line 10, by striking all following "act"; in line 11, by striking all preceding the period; and the bill be passed as amended.

(b) Nothing in this section shall limit the state corporation commission’s regulatory jurisdiction or authority to appeal to the federal energy regulatory commission any decision by a regional transmission organization or relieves the commission of its obligation and authority to ensure electric public utilities provide efficient and sufficient service.”;

A RESOLUTION advising the Compliance Review Committee for the Streamlined Sales and Use Tax (SST) Agreement that the state of Kansas is not substantially compliant with the SST Agreement.

WHEREAS, On July 1, 2005, Kansas and all other states that have filed petitions and certificates by May 1, 2005, will meet to vote on whether the petitioning states are in compliance based on recommendations of the Compliance Review Committee for the SST Agreement; and

WHEREAS, The State of Kansas has over 25,000 businesses affected by changes in Kansas law necessitated by SST Compliance requirements and according to the Kansas

Department of Revenue as much as 50% of these businesses are not collecting, reporting and remitting sales tax receipts in compliance with Kansas law; and

WHEREAS, Due to the documented difficulties of compliance, in a state with over 750 sales tax jurisdictions, with Kansas sales tax law related to destination-based sourcing, the Kansas Legislature and the Kansas Department of Revenue have chosen to disregard and to not enforce such law during a considerable amount of time since the original effective date of July 1, 2003; and

WHEREAS, Although many large retailers have complied with destination-based sourcing provisions, small retailers have been left free to ignore such provisions and most likely a majority of such retailers are currently noncompliant; and

WHEREAS, Kansas retailers' sales tax law has been judicially determined to be nonuniform which has allowed any city in Kansas to charter out of such sales tax law pursuant to home rule powers as provided in the Kansas Constitution; and

WHEREAS, It is not known with certainty how many cities in Kansas have availed or will avail themselves of this constitutionally-based home rule power; and

WHEREAS, Accordingly, cities in Kansas have the authority to make changes in local retailer's sales tax law which cause or will cause the State of Kansas to be noncompliant with clearly delineated requirements of the SST Agreement related to exemptions, rate uniformity, both intrastate and interstate, sourcing, collection and timing procedures and a myriad of other potential compliance requirements; and

WHEREAS, Neither the State of Kansas nor the Kansas Department of Revenue can clearly enforce Kansas Law enacted pursuant to the SST Agreement nor can they clearly compel cities to comply with Kansas retailers' sales tax law necessary for the State of Kansas to be substantially compliant with the requirements of the SST Agreement: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we advise the Compliance Review Committee for the Streamlined Sales and Use Tax (SST) Agreement that the State of Kansas is not substantially compliant with the SST Agreement; and

Be it further resolved: That the Chief Clerk of the House of Representatives is hereby directed to send an enrolled copy of this resolution to the Compliance Review Committee for the Streamlined Sales and Use Tax (SST) Agreement.
