A RESOLUTION congratulating the city of Horton on the 120th anniversary of its founding.

WHEREAS, On September 20, 2006, the city of Horton will be 120 years old. The city of Horton will celebrate this great event the week of September 15 to 21, 2006; and

WHEREAS, The first settlers moved into this area in 1855. Horton was part of the railroad expansion providing the site of a railroad shop and division point; and

WHEREAS, Horton was named in honor of Albert H. Horton, the first district judge of Brown County, and later the chief justice of the Kansas Supreme Court; and

WHEREAS, Horton grew at such a rapid rate it was also known as the “Magic City,” yet, in 1995, to recognize the first rural electrification cooperative in the state of Kansas, the Horton city commission officially recognized the city of Horton as the “Electric City”; and

WHEREAS, The Horton Headlight, the city’s first newspaper, began publication on October 29, 1886, and is still in operation today. On Horton’s second anniversary, the city had two newspapers, two banks, three churches, electric lights and a street railway; and

WHEREAS, Horton today is a rural community of 1,950 people and is the host of Better Beef Days in April, the Brown County 4-H Fair each July, and an arts and crafts show each September; and

WHEREAS, Cities such as Horton have given Kansas a strong past and provide hope for an even better future: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we congratulate the city of Horton on the 120th anniversary of its founding; and

HOUSE RESOLUTION No. 6029—

A RESOLUTION congratulating and commending the Paola Panther robotics team.

WHEREAS, Panther robotics team number 1108 of Paola was formed in 2002 to provide opportunities for high school students to develop their interest in technology, science and mathematics. The team competes yearly in FIRST Robotics competitions throughout the United States. This activity is sponsored by an organization known as FIRST, which is an acronym describing For Inspiration and Recognition of Science and Technology, an organization which has 1,200 teams worldwide; and

WHEREAS, Every year the FIRST organization creates a new challenge which is provided to all teams. With the task or challenge is a kit containing a control system and other

parts which are required to be used to construct the robot, but other operating parts and decisions as to how the robot is to be constructed are provided by the individual team. The team has six weeks to design and construct its robot which it may enter in competition at one of 30 regional competitions. Of the 1,200 teams competing, 350 qualify to compete at the world championship event, but only the regional champions are eligible to compete for the world champion award; and

WHEREAS, This year team 1108 has 22 student members who are assisted by 10 adult mentors. While not a school sponsored activity, the high school provides space for the team to meet, and two of the mentors are faculty members; and

WHEREAS, In partnership with the Kauffman Foundation, the team has worked to secure funds and recruit 26 new Kansas City area teams with the hope of having a regional competition at Kansas City in 2007. Locally the team has sponsored several workshops for elementary and middle school students, and at the college level has worked to establish scholarships for participants and to provide workshops for new robotics teams; and

WHEREAS, The team has been successful since its inception. In 2003, its first year in competition, the team received the regional Rookie All-Star Award and proceeded to the championship competition in Houston where it received the Championship Rookie All-Star Award. In 2004 the team received the Lone Star Regional Chairman's Award, in 2005 the Boilermaker Regional Chairman's Award and in 2006 the Wisconsin Regional Chairman's Award. The team received a first place award for the best open class float at the 2003 and 2005 Miami County Fair parades, and has been honored by receipt of a proclamation honoring the team by the mayor of Paola: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we congratulate and commend the Paola Panther Robotics team 1108 for its past success in robotics competition and wish it success at this year's worldwide competition.

HOUSE RESOLUTION No. 6030—

By Representative Kuether

A RESOLUTION recognizing the 150th anniversary of the dispersion of the free state legislature.

WHEREAS, One of our state's most exciting events occurred nearly 150 years ago on July 4, 1856, when Col. Edwin V. Sumner, on orders of Franklin Pierce, President of the United States, dispersed the free state legislature meeting in Constitution Hall—Topeka; and

WHEREAS, Historians have said that if shots had been fired that day on Kansas Avenue, the Civil War would have begun then, five years earlier than it did; and

WHEREAS, The Kansas Legislature in 1998 appropriated funds to Friends of the Free State Capitol to purchase Constitution Hall—Topeka, thereby preventing its demolition and assisting in steps toward its restoration; and

WHEREAS, The National Park Service in 2001 registered Constitution Hall—Topeka for its importance in drafting the state's first free state constitution and for being a historic site of the underground railroad; and

WHEREAS, The Kansas State Historical Society in 2005 recognized that Constitution Hall—Topeka is a nationally significant historic site eligible for listing in the National Register of Historic Places; and

WHEREAS, Efforts are being made for the summer of 2006 in downtown Topeka to celebrate the 150th anniversary of the dispersion of the free state legislature: Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: In recognition of the glorious history of the State of Kansas, we commemorate the 150th anniversary of the dispersion of the free state legislature.

There being no objection, the following remarks of Rep. Kuether are spread upon the Journal:

Today we begin to conclude the 2006 session of the Kansas Legislature. Yes, we still struggle to find ways to fund the important programs and projects of the Great State of Kansas; ever mindful of the legacy we leave our children and grandchildren. Let us pause for a brief moment to reflect on an event before our statehood in 1861.

I am talking about a monumentally dramatic and important event that occurred just five blocks east of here 150 years ago, on the Fourth of July in 1856. Two years earlier, upon the passage of the Kansas-Nebraska Act in Congress, New Englanders began to settle in Kansas Territory. Rather than see slavery spread westward, they endured great hardships to live where they could cast ballots for a Free State.

To draft a Free State constitution which they would submit in Congress, Free State settlers held their constitutional convention in Constitution Hall. It was the first stone building in Topeka and now with a modern front, it stands yet today on Kansas Avenue across from the downtown post office.

I add that the Free State Constitution, in a process we know well, came about after much study, discussion and compromise. When this constitution failed in congress by two votes, demoralized Free State settlers reconvened the Free State legislature to meet on July 4, 1856. Legislators had been elected, along with Charles Robinson as Free State Territorial governor, who would later be elected the first governor of Kansas.

When that July 4 arrived, however, things were in disarray. Robinson had been captured by the pro-slavery forces and was being held captive near Lecompton. Midmorning on the Fourth of July, the women and children were celebrating Independence Day. The men were inside Constitution Hall. Then came what is known as the Dispersion of the Free-State Legislature. It involved Franklin Pierce, the proslavery U.S. president who had given orders to disperse this legislature. Col. Edwin Sumner of Forth Leavenworth was the man chosen to carry it out. Sumner was an abolitionist, sympathetic to the Free State cause.

Various first-hand accounts of this exciting event in Kansas history are in the record, but today we hear that of J.P. Root. Root had come to Kansas from Connecticut with Beecher Bible and Rifle colonists at Wabaunsee. A physician, he soon moved to Wyandotte to practice medicine. He was the first Lt. Governor of Kansas. Today, we are pleased that Mr. Root's account will be presented by the current Lt. Governor of Kansas, the Honorable John Moore.

Rep. Kuether introduced Lt. Gov. John Moore, the 46th Lt. Governor, who read a letter by J.P. Root from 1856 to the members of the House.

Rep. Gordon introduced the following who accompanied Lt. Gov. John Moore to the House: Chris Meinhardt, Don Lambert, Michael Stubbs and Doug Wallace.

HOUSE RESOLUTION No. 6027—

By Representative Ballard

A RESOLUTION congratulating and commending Max Falkenstien upon his retirement after 60 years of broadcasting Kansas University (KU) sporting events.

WHEREAS, Following the final game of the 2005-06 men's basketball season, Hall of Fame broadcaster Max Falkenstien retired as color commentator on the University of Kansas radio network. In his 60 seasons of covering Jayhawk football and basketball, Max broadcast some 1,750 KU basketball games, including every game ever played in Allen Fieldhouse, and 650 KU football games; and

WHEREAS, The Naismith Basketball Hall of Fame and the College Football Hall of Fame both have honored Falkenstien. He has been inducted into the State of Kansas Sports Hall of Fame and the KU Athletics Hall of Fame, and was the first inductee of the Lawrence High School Hall of Honor. The Sporting News in 2001 named Falkenstien "the best college radio personality in the country." In addition, he has been awarded an honorary "K" by the Kansas Letterman's Club; and

WHEREAS, Falkenstien broadcast his first basketball game—an NCAA tournament game in Kansas City between KU and Oklahoma A&M on March 18, 1946. His next broadcast was KU's football opener against Texas Christian University on September 21, 1946. He served as the play-by-play voice of the Jayhawks for 39 years, and switched to the commentator's role in September 1984, when Bob Davis assumed the play-by-play duties. This duo has become so well known over the last 20 years that they are referred to simply as "Bob and Max." Television's Dick Vitale selected Bob and Max to his "Sweet 16" of the best college basketball announcing teams in the country; and

WHEREAS, Max also broadcast on television. He provided the play-by-play for the Big 8 Conference men's basketball Game of the Week between 1968 and 1971. For more than three decades he hosted football and basketball coaches' television shows, including those with Don Fambrough, Pepper Rogers, Mike Gottfried, Ted Owens, Larry Brown and Roy Williams; Now, therefore,

Be it resolved by the House of Representatives of the State of Kansas: That we congratulate and commend Max Falkenstien upon his retirement from 60 years of broadcasting Kansas University sporting events and thank him for the standard of excellence he established as the voice of KU football and basketball, and for the hours of enjoyment he provided to listeners through his vivid commentary and enthusiastic delivery; and

Be it further resolved: That the Chief Clerk of the House of Representatives provide an enrolled copy of this resolution to Representative Ballard for presentation to Mr. Falkenstien.

MESSAGE FROM THE SENATE

Announcing the Senate herewith transmits the veto message from the Governor on **SB 461**, An act concerning workers compensation; relating to preexisting condition; permanent partial general disability; amending K.S.A. 44-510e and K.S.A. 2005 Supp. 44-501 and repealing the existing sections.

which was received on March 21, 2006 and was read before the Senate on March 21, 2006.

Message to the Senate of the State of Kansas:

Kansas is an attractive place to do business and part of the reason for that is our low workers' compensation costs. Kansas' workers compensation rates are currently the eighth lowest in the nation, and employers have saved nearly \$113 million since the 1993 reforms were passed. At a time when most other insurance costs are rising, workers' compensation insurance premiums in our state will decline by 2 percent this year, saving our businesses an estimated \$3.5 million.

Benefits paid to workers injured on the job are the seventh lowest in the nation, and last year I signed a bill that makes it so Kansas businesses don't have to pay benefits to employees for drug or alcohol-related accidents. Additionally, pre-existing medical conditions are already factored into benefits, calling into question the need for this legislation.

Legislators would have been well-advised to listen to the veterans, fire fighters, nurses and seniors who all expressed their strong opposition to this bill.

Veterans have told me they're appalled that the physical hardships they endured during their military service would be used against them and I share their concerns. As Charles Yunker, Adjutant of the American Legion, Department of Kansas, testified, "Even those soldiers, sailors, airmen and Marines not wounded or otherwise injured will be impacted simply because of the demands placed upon them during active duty." Following World War II, Kansas changed its laws to make sure returning veterans could easily re-enter the workforce. During a time when we have thousands of Kansans serving overseas, the idea of penalizing them for their military service is outrageous.

The Legislature's proposal would also allow a worker to be terminated simply because of an injury on the job. That's a slap in the face to the men and women who work hard every day to do their jobs in a safe and efficient manner, and it's simply wrong.

Therefore, in order to protect our workers and our veterans, pursuant to Article 2, Section 14 of the Constitution of the State of Kansas, I veto **SB 461**.

“(i) Except as further provided, if a juvenile has been adjudged to be a juvenile offender for an offense that if committed by an adult would constitute the commission of: (1) Aggravated trafficking, as defined in K.S.A. 2005 Supp. 21-3447, and amendments thereto, if the victim is less than 14 years of age; (2) rape, as defined in subsection (a)(2) of K.S.A. 21-3502, and amendments thereto; (3) aggravated indecent liberties with a child, as defined in subsection (a)(3) of K.S.A. 21-3504, and amendments thereto; (4) aggravated criminal sodomy, as defined in subsection (a)(1) or (a)(2) of K.S.A. 21-3506, and amendments thereto; (5) promoting prostitution, as defined in K.S.A. 21-3513, and amendments thereto, if the prostitute is less than 14 years of age; (6) sexual exploitation of a child, as defined in subsection (a)(5) or (a)(6) of K.S.A. 21-3516, and amendments thereto; or (7) an attempt, conspiracy or criminal solicitation, as defined in K.S.A. 21-3301, 21-3302 or 21-3303, and amendments thereto, of an offense defined in parts (1) through (6); the court shall issue an order prohibiting the juvenile from attending the attendance center that the victim of the offense attends. If only one attendance center exists, for which the victim and juvenile are eligible to attend, in the school district where the victim and the juvenile reside, the court shall hear testimony and take evidence from the victim, the juvenile, their families and a representative of the school district as to why the juvenile should or should not be allowed to remain at the attendance center attended by the victim. After such hearing, the court may issue an order prohibiting the juvenile from attending the attendance center that the victim of the offense attends.”;

MR. PRESIDENT and MR. SPEAKER: Your committee on conference on House amendments to **SB 375**, submits the following report:

The Senate accedes to all House amendments to the bill, and your committee on conference further agrees to amend the bill, as printed with House committee amendments, as follows:

On page 20, by striking all in lines 12 through 23, following line 23 by inserting:

“New Sec. 6. (a) As used in this section:

(1) “State board” means the state board of regents.

(2) “State educational institution” has the meaning ascribed thereto in K.S.A. 76-711, and amendments thereto.

(3) “Leave time” means vacation leave and discretionary day leave.

(b) The state board may adopt a policy which authorizes state educational institutions to provide leave time to the classified employees of any such institution in an amount not to exceed the amount of leave time provided to unclassified employees of such institution.

(c) Subject to the policy of the state board adopted pursuant to this section, each state educational institution may provide leave time to classified employees of such institution. The amount of leave time may vary from the amount of leave time provided to classified employees of state agencies that are not state educational institutions.

(d) The state board shall adopt any rules and regulations necessary to implement the provisions of this act.

Sec. 7. K.S.A. 2005 Supp. 76-729 is hereby amended to read as follows: 76-729. (a) Persons enrolling at the state educational institutions under the control and supervision of the state board of regents who, if such persons are adults, have been domiciliary residents of the state of Kansas or, if such persons are minors, whose parents have been domiciliary residents of the state of Kansas for at least 12 months prior to enrollment for any term or session at a state educational institution are residents for fee purposes. A person who has been a resident of the state of Kansas for fee purposes and who leaves the state of Kansas to become a resident of another state or country shall retain status as a resident of the state of Kansas for fee purposes if the person returns to domiciliary residency in the state of Kansas within 12 months of departure. All other persons are nonresidents of the state of Kansas for fee purposes.

(b) The state board of regents may authorize the following persons, or any class or classes thereof, and their spouses and dependents to pay an amount equal to resident fees:

(1) Persons who are employees of a state educational institution;

(2) persons who are in military service;

(3) persons who are domiciliary residents of the state, who were in active military service prior to becoming domiciliary residents of the state, who were present in the state for a period of not less than two years during their tenure in active military service, whose domiciliary residence was established in the state within 30 days of discharge or retirement from active military service under honorable conditions, but whose domiciliary residence was not timely enough established to meet the residence duration requirement of subsection (a);

(4) persons having special domestic relations circumstances;

(5) persons who have lost their resident status within six months of enrollment;

(6) persons who are not domiciliary residents of the state, who have graduated from a high school accredited by the state board of education within six months of enrollment, who were domiciliary residents of the state at the time of graduation from high school or within 12 months prior to graduation from high school, and who are entitled to admission at a state educational institution pursuant to K.S.A. 72-116, and amendments thereto;

(7) persons who are domiciliary residents of the state, whose domiciliary residence was established in the state for the purpose of accepting, upon recruitment by an employer, or retaining, upon transfer required by an employer, a position of full-time employment at a place of employment in Kansas, but the domiciliary residence of whom was not timely enough established to meet the residence duration requirement of subsection (a), and who are not otherwise eligible for authorization to pay an amount equal to resident fees under this subsection; ~~and~~

(8) persons who have graduated from a high school accredited by the state board of education within six months of enrollment and who, at the time of graduation from such a high school or while enrolled and in attendance at such a high school prior to graduation therefrom, were dependents of a person in military service within the state; if the person, whose dependent is eligible for authorization to pay an amount equal to resident fees under this provision, does not establish domiciliary residence in the state upon retirement from military service, eligibility of the dependent for authorization to pay an amount equal to resident fees shall lapse; *and*

(9) *persons who have retired or have been honorably discharged from military service, had a permanent change of station order for active duty in Kansas during such military service and live in Kansas at the time of enrollment.*

(c) (1) The state board of regents shall authorize the following class of persons to pay an amount equal to resident fees: Any dependent or spouse of a person in military service who is reassigned from Kansas to another duty station so long as such dependent or spouse continues to reside in Kansas.

(2) So long as a person remains continuously enrolled, exclusive of summer sessions, a person who qualifies to pay resident fees by virtue of being a spouse or dependent of a person in military service shall not lose such status because of a divorce or the death of a spouse.

(d) As used in this section:

(1) "Parents" means and includes natural parents, adoptive parents, stepparents, guardians and custodians.

(2) "Guardian" has the meaning ascribed thereto by K.S.A. 59-3051, and amendments thereto.

(3) "Custodian" means a person, agency or association granted legal custody of a minor under the Kansas code for care of children.

(4) "Domiciliary resident" means a person who has present and fixed residence in Kansas where the person intends to remain for an indefinite period and to which the person intends to return following absence.

(5) "Full-time employment" means employment requiring at least 1,500 hours of work per year.

(6) "Dependent" means: (A) A birth child, adopted child or stepchild; or

(B) any child other than the foregoing who is actually dependent in whole or in part on the person in military service and who is related to such individual by marriage or consanguinity.

(7) "Military service" means any active service in any armed service of the United States and any active state or federal service in the Kansas army or air national guard.

Sec. 8. K.S.A. 72-116 is hereby amended to read as follows: 72-116. (a) Any person who ~~completes a four-year course of study in~~ *graduates from* any high school accredited by the state board of education and who meets the admission requirements established by the state board of regents pursuant to K.S.A. 76-717, and amendments thereto, shall be entitled to admission to the freshman class of the state educational institutions which are under the control and supervision of the state board of regents upon presenting a statement containing a transcript of the high school record of the person signed by the principal of the school or superintendent of the school district and certifying that the person has satisfactorily completed the course requirements of the state board of education necessary for graduation from high school.

(b) *Any person who is a resident of the state of Kansas, who graduates from an accredited high school located outside the state of Kansas and who meets the admission requirements established by the state board of regents pursuant to K.S.A. 76-717, and amendments thereto,*

for persons who have graduated from an accredited Kansas high school shall be entitled to admission to the freshman class of the state educational institutions which are under the control and supervision of the state board of regents upon presenting a statement containing a transcript of the high school record of the person signed by the principal of the school or superintendent of the school district and certifying that the person has satisfactorily completed the course requirements necessary for graduation from high school.

Sec. 9. K.S.A. 72-60b02 is hereby amended to read as follows: 72-60b02. The members of the midwestern higher education commission representing the state of Kansas shall be the following: (a) The governor or a designee of the governor; (b) two members of the legislature appointed by the legislative coordinating council so that one is a member of the senate and one is a member of the house of representatives and such members are not members of the same political party; and (c) two members of the state board of regents selected by the state board or, at the discretion of the state board, designees thereof. One such member shall be representative of the four-year institutions of higher education and one such member shall be representative of the two-year institutions of higher education. The term of the member serving under subpart (a) shall expire concurrently with the term of the governor. The terms of members serving under subpart (b) shall expire concurrently with their terms as state officers or two years after the date of their appointment to membership on the commission, whichever occurs sooner, *except that legislative members serving on the commission's executive committee may serve up to one additional two-year term while serving on such executive committee.* The term of each member serving under subpart (c), if such member is a state officer, shall expire concurrently with such member's term as a state officer or four years after the date of appointment to membership on the commission, whichever occurs sooner. If such member is not a state officer, the term of such member shall expire four years after the date of appointment to membership on the commission. All vacancies in the membership of the commission shall be filled in the same manner as originally filled, except that vacancies created for reasons other than expiration of terms of office shall be filled for the unexpired terms.;

A RESOLUTION congratulating and commending the Kansas State University women's basketball team and head coach Deb Patterson.

WHEREAS, The Kansas State University women's basketball team defeated Marquette University to become the 2005-06 WNIT champions, the first postseason championship title in the school's history. The team finished the year with a record of 24 wins to 10 losses and was eight to eight in league play. This year was the fifth consecutive 20-win season for the team and the fifth consecutive appearance in postseason competition. The team played 19 games at Bramlage Coliseum and in five overtime games throughout the year; and
