**SP 4**, by Senator Tim Huelskamp: A petition calling upon the Kansas Legislature to pass a Constitutional Amendment to the fundamental doctrine of Separation of Powers by declaring that the Judiciary has no authority to appropriate taxpayers funds and that such power is reserved exclusively to those elected to the Legislature by the citizens of Kansas, submitted by Donald L. Dowell, Flower, Kansas and 230 other constituents across the state of Kansas.
