

SENATE WAYS AND MEANS COMMITTEE

Minutes of the Meeting
January 11, 1962

The meeting was called to order by Chairman Lauterbach at 9:00 a.m. on January 11, 1962. All the members were present except Senator Hults.

Messrs. Carl Glatt and Homer Floyd appeared before the committee on behalf of the Commission on Civil Rights. Restoration was requested of the following items:

1. An additional field representative
2. \$1,000 in printing
3. \$200 in communications
4. Travel for the additional field representative

Mr. Roger Kirkwood appeared before the committee on behalf of the Centennial Commission. Mr. Kirkwood said that the final report of the Commission is now in the hands of the printer and should be available very soon. The chairman asked Mr. Kirkwood if he would refer to the letter addressed to the Commission on February 4, 1960. In this letter it was stated that the funds being advanced to the Commission were for the purpose of making contracts for medallions, etc. and that the cost of these items would be recovered by resale. The chairman then asked Mr. Kirkwood if the committee could have a final report with these items listed separately.

Mr. Lynn Burris and a number of interested parties appeared before the committee on behalf of the budget of the State Park and Resources Authority. Mr. Burris said that they had studied the recommendations of the Governor and felt that the amount allowed would permit them to operate and to develop the five state parks now under this authority. He did ask for additional consideration of the following items:

1. \$8,000 for a grader to be used on the roads at the park areas
2. Restoration of money requested for Pomona Reservoir
3. Park roads to be installed by the Highway Department. If the Highway Department does not plan to do this work, then the Authority would like \$300,000 for this purpose.
4. \$250,000 for the Prairie National Park. This item was included in the budget of the Authority but was not their request. It is the understanding of Mr. Burris that this money is to be used for the purchasing of land.

Senator Van Sickle made a motion, seconded by Senator Glades, that the subcommittee's reports on the following agencies be approved and incorporated into a bill:

1. Centennial Commission
2. Eisenhower Presidential Library Commission
3. Highland Presbyterian Mission
4. Kansas State Historical Society
5. John Brown Memorial State Park
6. Kansas Frontier Historical Park
7. Marais des Cygnes Massacre Memorial Park
8. Pawnee Rock Historical Park
9. Washington County Historic Pony Express Station.

The motion carried.

A supplemental appropriation in the amount of \$2,000 to complete the new elevator project in the Memorial Building is included in the estimated expenditures. (for fiscal year 1962) This money will be used to enclose two elevator shafts, move water and electric lines, and incorporate drinking fountains in the new enclosures.

An amount of \$5,846 is also included in the fiscal year 1962 budget for state retirement contributions and the increase in social security rates effective January 1, 1962.

The fiscal year 1963 capital improvement budget includes an amount of \$1,000 for interior painting and plastering for the Memorial Building; \$200 for furnace repairs and \$300 to repair an existing restroom and to install a new restroom at Old Indian Mission; \$750 to waterproof the East Building and \$1,000 to shingle the West Building and garage at Old Shawnee Mission.

Your subcommittee recommends that the budget of the Kansas State Historical Society be approved as recommended by the Governor.
