EDUCATION COMMITTEE

Minutes

The thirty-fourth meeting of the Education Committee convened at 2:00 P.M., Friday afternoon, March 29, 1963 in Room 524 with Vice-Chairman Dixon presiding. All the members were present except Messrs. Dreiling, Nesmith, Smith, Teter and Tillotson.

SENATE BILL No. 430:

After a discussion of this bill, the motion was made by Mr. Crow, seconded by Mr. Hughes, that Senate Bill No. 430 be amended. The motion carried unanimously.

The motion was made by Mr. Harder, seconded by Mr. Lill, that Senate Bill No. 430 be recommended favorably for passage as amended. The motion carried unanimously.

Subcommittee report, foundation program:

Mr. Finney made the motion, seconded by Mr. Lill, that the subcommittee report on the Foundation Program on the basis of 67% implementation together with restrictions and modifications as outlined to the Committee the previous day including the 4B section, be submitted as a Committee bill to be referred back to the Committee. The motion carried.

Legislative Council Study of reorganization of districts:

Mr. Bower made the motion, seconded by Mr. Casado, that the Committee introduce this study as an aid to solve problems resulting from House Bill No. 377. The motion carried unanimously.

State Superintendent of Public Instruction Throckmorton appeared before the Committee explaining Senate Bills Nos. 266, 267 and 268.

SENATE BILL No. 266:

After a discussion of this bill, the motion was made by Mr. McCall, seconded by Mr. Vogel, that the Committee recommend Senate Bill No. 266 favorably for passage. The motion carried unanimously.

SENATE BILL No. 267:

After a discussion of this bill, the motion was made by Mr. McCall, seconded by Mr. Vogel, that the Committee recommend Senate Bill No. 267 favorably for passage. The motion carried unanimously.

SENATE BILL No. 268:

After a discussion of this bill, the motion was made by Mr. McCall, seconded by Mr. Vogel, that the Committee recommend Senate Bill No. 268 favorably for passage. The motion carried unanimously.

Mr. McCall, Chairman of the subcommittee consisting of Messrs. Hughes and Crow, reported to the Committee on Senate bills Nos. 188 and 189 relating that these are companion bills; Senate Bill No. 188 providing for the transfer of people with retirement systems in cities of the first class to the State system and Senate Bill No. 189 stating the dates that the transfer is effective.

SENATE BILL No. 188:

Mr. Hughes made the motion, seconded by Mr. Harder, that Senate Bill No. 188 be recommended favorably for passage. The motion carried unanimously.

SENATE BILL No. 189:

The motion was made by Mr. Hughes, seconded by Mr. Harder, that Senate Bill No. 189 be recommended favorably for passage. The motion

carried unanimously.
