

HOUSE OF REPRESENTATIVES

EDUCATION COMMITTEE

Minutes

The thirty-sixth meeting of the Education Committee convened at 4:00 P.M., Tuesday afternoon, April 2, 1963 in Room 522 with Chairman Bower presiding. All the members were present except Mr. Dreiling.

SENATE BILL No. 434:

Mr. McCall, Chairman of the subcommittee consisting of Messrs. Hughes and Crow, reported to the Committee favorably on Senate Bill No. 434.

The motion was made by Mr. McCall, seconded by Mr. Vogel, that Senate Bill No. 434 be recommended favorably for passage. The motion carried unanimously.

SENATE BILL No. 425:

Mr. Bower read a proposed amendment to the Committee for Senate Bill No. 425. It was agreed to restore the part deleted by the Senate pertaining to transportation and delete Line 26 through 34 including the word "year," and inserting language making tuition rates more equitable in joint districts.

Mr. Robinson made the motion, seconded by Mr. Lill, that Senate Bill No. 425 be amended. The motion carried unanimously.

The motion was made by Mr. Casado, seconded by Mr. Tillotson, that Senate Bill No. 425 be recommended favorably for passage as amended. The motion carried unanimously.

HOUSE BILL No. 448:

After a discussion of this bill, Mr. Smith made the motion, seconded by Mr. Boyd, that the Committee recommend House Bill No. 448 adversely.

Mr. Lill made the substitute motion, seconded by Mr. Casado, that the bill be recommended favorably for passage. Mr. Lill then withdrew his motion so that Mr. Finney could make a substitute motion, seconded by Mr. Casado, that House Bill No. 448 be amended providing for a 60% distribution and deduction of 30% of the VLH 74 funds rather than 50%. The amendment carried with a vote of nine for the amendment and eight against.

Mr. Casado made the motion, seconded by Mr. Finney, that the House Bill No. 448 be recommended favorably for passage as amended. The motion failed with a vote of eight for passage and ten against.

Mr. Smith renewed his motion to report House Bill No. 448 adversely. The motion carried with a vote of ten for killing the bill and seven against.

HOUSE BILL No. 152:

After a discussion of this bill, Mr. Casado made the motion, seconded by Mr. Hughes, that House Bill No. 152 be recommended favorably for passage to be referred to the Committee of the Whole. The motion carried unanimously.

Introduction of a Committee bill: Mr. Casado made the motion, seconded by Mr. Gruver, that the Committee introduce a bill for the clarification of the use of funds from certain tax levies to be referred to the Committee of the Whole. The motion carried unanimously.

SENATE BILL No. 264:

After a discussion of this bill, Mr. Casado made the motion, seconded by Mr. Hughes, that Senate Bill No. 264 be recommended favorably for passage. The motion carried unanimously.

The meeting adjourned at 5:25 P.M.
