

House Judiciary Committee Meeting

The House Judiciary Committee met Wednesday, February 24, 1965, in Room 523 at 3:00 P.M. with Chairman Jack R. Euler presiding. Twelve members were present. Members Amrein, Barnhill, Bell, Cram, Fatzer, Hill, Sargent, Tillotson and Van Cleave were absent.

Chairman Euler called the meeting to order. The committee resumed its consideration of the Act for Obtaining a "Guardian" or "Conservator".

Proposed Provision to be Included in the Act  
Providing Care or Treatment for Mentally Ill Persons

"Be it further enacted that no person who is being treated by prayer in the practice of the religion of any church which teaches reliance on spiritual means alone through prayer for healing may be ordered detained, or committed under the provisions of this Act unless substantial evidence is produced upon which the court finds in addition to the other findings required by this Act, that he is or would be likely to become dangerous to himself or the person or property of others, or unless he or his legal guardian, if any, consents to such detention or commitment."
