

ROADS AND HIGHWAYS COMMITTEE MEETING -- January 17, 1972

The Roads and Highways Committee met in room 510 S at 2:45 P. M. on January 17, 1972. Chairman Dierdorff called the meeting to order and all members were present except Representatives Arbuthnot, Dugan, Ossmann and Wingert.

Merritt Buffon of Legislative Research was the conferee on the interim committee reports for the Special Committee on Transportation.

1. House Bills Nos. 1016 and 1126 - Driver Re-examination - pages 664-672: Mr. Davis made a motion, second by Mr. Jacobs, that the committee report be adopted. Motion carried.

Mr. Lady made a motion, second by Mr. Rosenau, that House Bills Nos. 1016 and 1126 be not passed. Motion carried.

2. Railroad Crossings - pages 699-707: Mr. Davis made a motion, second by Mr. Gray, that the committee report be adopted. Motion carried.

3. House Bill No. 1499 - Reflectorized license tags - page 708: Dr. Hughes made a motion, second by Mr. Spotts, that the committee report be adopted. Motion carried.

4. Liquefied Petroleum Gas Law - page 695: Mr. Hayes made a motion, second by Mr. Davis, that the committee report be adopted. Motion carried.

5. SCR No. 43 - Scenic Highways - page 709: Mr. Davis made a motion, second by Mr. Wilson, that the committee report be adopted. Motion carried.

6. House Bill No. 1560 - Suspension of Drivers Licenses - page 664: Mr. Wilson made a motion, second by Mr. Davis, that the committee report be adopted. Motion carried.

Mr. Hayes made a motion, second by Dr. Hughes, that House Bill 1560 be not passed. Motion carried.

7. Ports of Entry - pages 696-699: Mr. Wilson made a motion, second by Mr. Davis, that the committee report be adopted. Motion carried.

8. House Bill No. 1127 - Colored Photo on License - page 663: Mr. Ratner made a motion, second by Mr. Davis, that the committee report be accepted but not to report the bill adversely - to consider it at the time of the Driver Re-examination bill. Motion carried.

9. Local Bond Financing of Highways - pages 695-696: Mr. Hayes made a motion, second by Mr. Lady, that the committee report be adopted. Motion carried.

Representative Dierdorff reported to the committee that Helen Krahn, representing K. O. A., had made a request to appear before the Roads and Highways Committee.

Mr. Hayes made a motion, second by Mr. Ratner, that Mrs. Krahn and her representatives be invited to appear. Motion carried.
