

ROADS AND HIGHWAYS COMMITTEE MEETING - FEBRUARY 8, 1972

The Roads and Highways Committee met in room 510 S at 2:45 P. M. on February 8, 1972. Chairman Dierdorff called the meeting to order and all members were present except Dugan, Ossmann, Steffes & Weaver. Merritt Buffon and Dick Long represented Legislative Research.

Conferees were: Harold B. Turntine, Motor Vehicle Department, on House Bills Nos. 1943, 1944, 1986, 1988, 2008; L. A. Byers, Motor Vehicle Department, on House Bill 2006.

Mr. Turntine and Mr. Byers explained the bills. They were all bills that had been sent over from the State Highway Director with the recommendation that they be introduced as Committee bills.

HOUSE BILL 1944 - AN ACT relating to motor vehicles; designating persons to whom an operator's license shall not be issued, providing for exceptions to the same, and providing for restricted operator's licenses and the conditions under which the same may be issued; amending KSA 8-237 and repealing the existing section.

Mr. Hayes made a motion, second by Mr. Allison, that HB 1944 be reported favorably. The motion carried.

HOUSE BILL 1943 - AN ACT relating to motor vehicles requiring written reports by drivers of motor vehicles involved in accidents; amending KSA 1971 Supp. 8-523 and repealing the existing section.

Mr. Hayes made a motion, second by Mr. Davis, that HB 1943 be amended on page 2, line 14, by striking "five (5)" and inserting in lieu thereof "ten (10)". The motion carried.

Mr. Davis made a motion, second by Mr. Rosenau, that HB 1943 be passed as amended. The motion carried.

HOUSE BILL 1986 - AN ACT relating to motor vehicles; concerning the operation thereof by a person under the influence of intoxicating

liquor or narcotic drugs; amending KSA 1971 Supp. 8-530 and repealing the existing section.

Mr. Davis made a motion, second by Dr. Hughes, that HB 1986 be passed. The motion carried.

HOUSE BILL 1988 - AN ACT relating to motor vehicles; pertaining to the expiration date of operator's licenses, and providing notice of expiration date and effect for failure to apply for renewal of license, amending KSA 1971 Supp. 8-247, and repealing the existing section.

Mr. Hayes made a motion, second by Mr. Allison, that HB 1988 be passed and placed on the Consent Calendar. The motion carried.

HOUSE BILL 2006 - AN ACT relating to special license plates for antique motor vehicles; amending KSA 8-172 and repealing the existing section.

Mr. Davis made a motion, second by Dr. Hughes, that HB 2006 be passed and placed on the Consent Calendar. The motion carried.

HOUSE BILL 2008 - AN ACT relating to motor vehicles; providing for the issuance of duplicate instruction permits and operator's licenses; amending KSA 8-246 and repealing the existing section.

Mr. Lady made a motion, second by Mr. Wingert, that HB 2008 be passed and placed on the Consent Calendar. The motion carried.

The Chairman asked for permission to have Substitute Bills Nos. 2064 and 2065 introduced. Mr. Wingert made a motion, second by Mr. Lady, that the bills be introduced. The motion carried.

The meeting was adjourned.
