

ROADS AND HIGHWAYS COMMITTEE MEETING - MARCH 9, 1972

The Roads and Highways Committee met in room 510 S at 2:45 P. M. on March 9, 1972. Chairman Dierdorff called the meeting to order and all members were present except Allison, Davis, Dempsey, Dugan, Hughes and Wilson.

The following action was taken:

SENATE CONCURRENT RESOLUTION 79 - A SCR authorizing and directing the Kansas state highway commission to conduct a study of the feasibility, cost of financing and legal authority for establishing, improving and developing that certain property located in Ellis county and known as "Custer Island" as a highway rest area or park facility; and requiring a report and recommendations to be made to the 1973 session of the legislature.

Mr. Ratner made a motion, second by Mr. Hayes, that SCR 79 be amended in line 2, by striking "and directed" in line 9, by striking "shall" and inserting in lieu thereof "may"; in line 1 of the title by striking "and directing"; in line 6 of the title, by striking "requiring" and inserting in lieu thereof "requesting". The motion carried.

Mr. Jacobs made a motion, second by Mr. Nowlin, that SCR 79 be adopted as amended. The motion carried.

SENATE CONCURRENT RESOLUTION 109 - A SCR providing for a special committee to make a legislative study concerning the state system of expressways and freeways.

Mr. Ratner made a motion, second by Mr. Spotts, that SCR 109 be adopted. The motion carried.

SENATE CONCURRENT RESOLUTION 110 - A SCR providing for a special committee to make a legislative study concerning the ports of entry.

Mr. Jacobs made a motion, second by Mr. Rosenau, that SCR 110 be adopted. The motion carried. (Nowlin - No)

HOUSE CONCURRENT RESOLUTION 1145 - A CONCURRENT RESOLUTION providing for a special committee to make a legislative study concerning wheel and axle loads of vehicles using state roads and highways.

Mr. Jacobs made a motion, second by Mr. Hayes, that HCR 1145 be tabled. The motion carried.


SENATE BILL 735 - AN ACT concerning automobiles and other motor vehicles; declaring it unlawful to drive while license canceled,.....
